IV. **Representations, Covenants and Agreements of Applicant for New Service.**

Applicant, in consideration of the issuance of the permit to make a connection to the waterline, to excavate in the public right a way and to obtain water service does hereby represent, covenant and agree:

1. To perform faithfully and with due care and skill the work of excavating and making the connection to the City water main and in accordance with all applicable codes and regulations.
2. To pay all costs and expenses incident to the installation of the service line and connection with the City water line.
3. To indemnify and hold the City of Hermantown and its Utilities Commission harmless from any loss or damage that may be directly or indirectly occasioned by the installation of the service line and/or the connection of it to the City water main.
4. To comply with the requirements of the applicable ordinances and regulations of the City of Hermantown and other governmental bodies with respect to the construction and installation of such service line and the connection to the City water main.
5. To notify the City Superintendent when the service line is ready for inspection and connection to the City water main and allow the City Superintendent to inspect and approve such installation, including the installation with the building to be serviced by such service line, before a connection is made to the City water line.
6. To pay to the Utility Commission with this application a connection charge of \$800.00 for the purpose of paying for the construction, reconstruction, repair, enlargement, improvement, maintenance and operation of the entire water system of the City of Hermantown which amount accompanies this application.

7. To pay any assessment levied or to be levied against the property described herein for any benefits received by such property as the result of the construction of the water main adjacent to such property, or if no such levy has been made or will be made, to pay such amount as may be determined by application of the then policy of the Utility Commission for front foot water charges in cash or under a standard Utility Commission Water Service Agreement.
8. That the connection charge to be paid herewith is in addition to any assessment levied or to be levied against such property as such connection charge does not pay for any of the benefits that such property receives from the construction of the water main adjacent to such property, but rather is to pay for the items described in paragraph 6 hereof for the entire water system of the City of Hermantown.
9. To obtain and submit with this application any permit required for excavation in a County or State of Minnesota right of way from the St. Louis County Highway Department or the Minnesota Highway Department.
10. To verify the location of any other utilities in the area of excavation and to notify the owners of such utilities before starting any excavation.
11. To maintain the water service line from the building to be serviced with water to the City water main including the connection, in good condition at all times at the expense of the applicant.
12. To pay, when due, all charges made by the City for water service provided to the property described herein. In this regard, Applicant understands and agrees that should a delinquency occur in the payment of any amount owed to the Utility Commission for water service, that the Utility Commission may discontinue providing water service to applicant, certify the delinquent amount to the County Auditor for collection with real estates taxes due on such property and/or take whatever other actions are allowed by law to collect any such delinquent amount.

Applicant further acknowledges and understands that he/she/they must comply with all state regulations and statutes regarding wells on this property, and hereby acknowledges receipt of a pamphlet printed by the Minnesota Department of Health, which notes the applicant's responsibilities with regard to abandoned wells.
