Applicant, in consideration of the City continuing to provide applicant with access to the City sewer main, do(es) hereby agree(s) as follows:

1. To indemnify and hold the City of Hermantown and its Utility Commission harmless from any loss or damage that may be directly or indirectly occasioned by the use of the City sewer.
2. To comply with requirements of the applicable ordinances and regulations of the City of Hermantown and other governmental bodies with respect to the maintenance and use of such sewer line.
3. To allow the City Superintendent to inspect and approve the existing connection to the City sewer line, including the connection within the building to be served by such service line, if so required by the City Superintendent.
4. To maintain the sewer line from my (our) property to the City sewer main, including the connection in good condition at all times at my (our) expense.
5. To pay, when due all charges made by the City or any other governmental body for sewer services provided to the property described herein, including any assessments levied or to be levied against the property described herein and any connection charges that have not been previously paid.
6. That should a delinquency occur in the payment of any amount owed to the City or other governmental body for sewer service or assessments or connection charges that the City may certify the delinquent amount to the County Auditor for collection with the real estate taxes due on such property, may discontinue providing water service to such property, and/or may take whatever other actions are allowed by law to collect any such delinquent amount.
