

CITY OF HERMANTOWN DECK APPLICATION

BUILDING PERMITS ARE REQUIRED FOR ANY DECK THAT IS ATTACHED TO A BUILDING OR ANY DECK PLATFORM THAT IS ELEVEATED MORE THAN 30 INCHES ABOVE GRADE.

Information Necessary When Applying for a Building Permit

- Application for building permit
- Site Plan
- Construction Plan indicating overall dimensions, decking material, joist size and spacing, beam size, post/pier locations and dimensions, stair location, and guardrail information

Land Use Restrictions

 Setbacks from property lines and other structures vary depending upon the zoning district in which your home is located. Contact the Community Development staff for the requirements in your location. This is an important first step in the planning for any building project.

Building Code Requirements


- Frost Footings: Required for any deck that is attached to a building or any deck platform that is elevated more than 30 inches above grade. Minimum 60 inches depth below grade.
- Live Loads: All decks are to be designed for a minimum of 40 PSF live load, and balconies designed for 60 PSF live load.
- Ledger Boards: Ledgers are to be installed with proper flashing and attachment. Flashing
 material for ledger is to be of an approved material for contact with type/brand of treated
 wood. Ledger to be attached by lag bolting or through bolting to rim joist or solid
 blocking.
- Guardrails: Minimum 36-inch height with an opening that prevents the passing of a 4-inch sphere through the opening for one (1) and two (2) family dwellings.
- Stairs: Minimum 36-inch width, maximum 7 3/4-inch riser, minimum 10-inch tread depth, maximum variance of 3/8 inch in riser heights or tread depths, maximum of 4-inch opening in risers.


If deck is to be constructed over a required egress window, a minimum of 36-inch vertical clearance is to be provided between grade and the bottom of the framing for the deck.


Required Inspections
