<u>Information necessary when applying for a garage / accessory buildings permit:</u>

- Application for building permit
- Application for zoning certificate
- Site Plan
- Cross Section

Land Use Restrictions

Setbacks from property lines vary depending on the zoning district in which your home is located. They may also vary dependent on whether the garage / accessory building is attached to the home or detached. Additional zoning provisions may apply, like lot coverage, building height, or limitations to number and size of accessory structures on the lot. Contact the City (218.729.3600) for the requirements in your location. This is an important first step in planning for any garage / accessory building project.

Required Inspections


- Footing/Concrete Slab: To be made after all form work is set up, mesh laid, rods wired in, etc., but PRIOR TO THE POURING OF CONCRETE.
- Framing: To be made after all framing, blocking, sheathing, and bracing are in place.
- Final: To be made upon completion of the garage / accessory building and finish grading.
- Other Inspections: In addition to the three inspections above, the inspector may
 make or require other inspections to ascertain compliance with the provisions of
 the code or to assist you with your questions or concerns during the construction
 process.

CONCRETE GARAGE FLOOR MINIMUM STANDARDS FOR DETACHED GARAGE OVER 200 SQUARE FEET


General Notes

- Floor drains to daylight if provided
- Minimum 6" earth separation to wood framing
- Anchor Bolts: Minimum 7" embedment, maximum spacing is 6' o.c. within 12" of ends of sill plates
- Minimum 15" splice on rebars




Overhead Door Location: Gable End or Bearing Wall
