MS4 STATEMENT OF COMPLIANCE AGREEMENTS

By signing this agreement, you understand:

1. The Applicant, Landowner, and the Contractor conducting the work on the site are jointly responsible for all the construction activities that occur on the site.
2. The Applicant, Landowner, and Contractor are required to install and maintain all erosion and sediment control BMPs in accordance with the ESCP or SWPPP to ensure that sediment, soil, and debris does not leave the construction site. All parties are also responsible for the total restoration of vegetation on the site (seed/mulch, sod, gardens, etc.) after construction disturbance is

substantially complete, and only after vegetation has been established with vigorous growth can BMPs be cleaned and removed.

3. The Applicant, Landowner, and Contractor are required to construct the proposed Post-Construction Stormwater Management Best Management Practices (BMPs) per the plan. Any change in the proposed work or construction of additional impervious surfaces on the site will require additional Stormwater Management Plan review and approval
4. The Applicant, Landowner, and Owner's Engineer are responsible for conducting construction inspection and providing an As-Built Drawing of the Post-Construction Stormwater BMPs to ensure the stormwater BMPs/infrastructure are constructed per plan and supplied to the City Engineer per City Standards.
5. The Applicant and Landowner understand their responsibility of the ongoing operations and maintenance of the mentioned Post-Construction Stormwater BMPs. Annual inspection reports of the stormwater BMPs must be submitted to the City as required by the MPCA-MS4 Permit and the NPDES Federal Permit authorized under the Clean Water Act.
6. This permit does not authorize any work other than what is specifically described in the application and plans listed above, nor any work by anyone other than the applicant listed on the permit

I hereby acknowledge with my signature that I understand Sections 1060 and 1080 of the City Code governing Erosion and Sediment Control Requirements and Post-Construction Stormwater Runoff, respectively. I also consent that the City's designated representative/s may enter upon the property for purposes of inspection to determine compliance with erosion and sediment control requirements until the lot is fully stabilized. At the completion of final stabilization, the Applicant, Landowner, or Contractor is responsible to contact the City Building Official for final inspection. At this time, the permit will be terminated if the City Building Official deems the project stabilized and a record drawing has been submitted for the Post-Construction Stormwater Controls.

Stormwater Pollution Prevention Plan (SWPPP) Review Fee:

- Land Disturbance less than one (1) acre: \$150.00
- Land Disturbance one (1) acre to five (5) acres: \$300.00
- Land Disturbance more than five (5) acres: \$750.00

Stormwater Management Plan (SWMP) Review Fee:

- New and Redeveloped Improvement Area less than one (1) acre: \$250.00
- New and Redeveloped Improvement Area of one (1) acre to five (5) acres: \$500.00
- New and Redeveloped Improvement Area more than five (5) acres: \$750.00

Recording fee of \$46.00 required to receive MS4 Statement of Compliance.

1. If an Erosion Control and Fill Permit is required, the submission of a SWPPP is not applicable.
