a. **Legislative Update:** The Legislature is scheduled to be called back into Session on Monday June 14th. This is what we know right now:

facilities and upgrades to the Hermantown Hockey Arena; and

(2) \$4,570,000 for construction of the Hermantown-Proctor trail running from the Essentia Wellness Center to the border with Proctor and eventually connecting to the Munger Trail. Center to the border with Proctor and eventually connecting to the Munger Trail.

To date, we have not heard of any discussion by the Conference Committee which way they are leaning on this issue.

- b. **Inquiries for Federal Dollars:** We have submitted requests to both Representative Stauber's office and Senator Klobuchar's office. We were not included in the projects that were submitted by Representative Stauber's office. We have not heard back from Senator Klobuchar Those requests are attached for your information.
- c. **Referendum process** The City's limited role: We should have a brief discussion on the City's limited role in any referendum process.
- d. Naming Rights Discussion: During the Wellness Center project, we did not specifically request proposal for just naming the facility, instead, we asked for a medical partner, and the naming agreements came out of that process. The City Council previously discussed this issue, but more direction is needed. Specifically, what dollar amount would be sufficient to acquire the naming rights of the facility, and further discussion on that process.
- e. **School Discussions:** We (Jeff Schiltz and I) are scheduled to meet with the Wayne Whitwam on Thursday June 17th. Agenda includes:
 - Update on Hermantown Recreational Initiative
 - Potential land swaps.
 - Naming rights discussions (including the existing rink)
 - Other potential items such as locker rooms, ice plant, etc.

I don't think we should rule out the question of actual ownership of the arena

f. Construction Delivery Methods: I would like to begin the discussion of what method of construction the City might use, and what that scope of work might be, if the sales tax proposal passes the legislature and a referendum. As you will recall, that question became somewhat controversial during the discussion of the Essential Wellness Center. Jeff Schiltz of ICS has asked to do a presentation on the model used by ICS. I believe we should schedule that presentation in the next two months or so (assuming the sales tax

is passed by the legislature.) As you might imagine, there are other vendors who would likely want to present their model for delivery as well.

We may also want to discuss if the same method would be used for all of the projects.

5. Needs Statement *

Hermantown's Community Recreation Initiative is a three-component project aimed at improving the health outcomes of residents in southern St. Louis County, while providing an economic booster for the region. The three projects are a trail system connecting Hermantown and multiple communities to the state-wide Willard Munger trail in Minnesota, the reimagining and revamping of a central park utilized by members of multiple communities to create greater access to outdoor activities, and the construction of an indoor ice arena and reconfiguration of outdoor ice facilities to meet the overwhelming regional need on the sole current aging facility.

St. Louis County has struggled with county-wide health outcomes - which burden not only individual residents but also negatively impact the quality of life and the economy across the entire region. The Community Recreation Initiative is a significant step in providing accessible opportunities across a full spectrum of age, ability, and interest to more than 100,000 people. It does so with three component projects that will also bring economic positives into the area.

The total initiative cost is \$19.31 million, with \$4.57 million for the trail system, \$3.9 million for Fichtner Park, and \$10.84 million for the ice arena. All three of these projects are expected to have a positive health impact in our area, as these varied options can be utilized by people of varying interests and abilities. All three projects are also expected to have a positive economic impact on our area, through the creation of jobs, the attraction of much-needed visitors to this region, and more. Finally, all three projects provide extraordinary benefit beyond the City of Hermantown's borders, as our growing city provides a great deal of recreation opportunities for neighboring communities.

The reality of St. Louis County's substandard comparative health outcomes is not going to improve without clear investment. A significant first step has been taken and has proven successful with the Essentia Wellness Center – a multi-use facility brought into creation through a partnership with the City of Hermantown, private businesses, the local school district, and the state of Minnesota. The early success of this facility has allowed for the confidence in stepping forward in requesting this funding for the Community Recreation Initiative. While it is hard to quantify the economic gains of a healthy lifestyle, we know the debilitating costs, not to mention the physical impact of obesity, diabetes, and other cumulative negative health effects. We are trying to maximize St. Louis County's health through a focused investment of our sales tax. Should this prove to be successful, as it already has initially shown with the Essentia Wellness Center, the payback on this investment is immeasurable. The global health pandemic has also shown us that options need to be provided beyond a single building, no matter how dynamic that facility can be.

In Hermantown, we have taken a stand for health. Now, we want to extend that success beyond a single building and into the lives of our region's youngest softball players and skateboarders, our oldest skaters and shortstops, and all throughout our region with the newest, most accessible trail and path system. As we age, we know you cannot put a price on good health, but what you can put a number to is the investment in everyone's healthy recreation opportunities. We have placed that number at \$19.31 million for an area of impact north of 100,000 people.

6. Existing Resources *

In terms of existing resources, all three components of the Hermantown Community Recreation Initiative have the advantage of adding/updating an existing opportunity. The area, already well known for its hockey tradition, has maximized both an indoor and outdoor facility that is reaching the end of its usable life. This investment would extend what is already in place while adding a critical update in an area of incredible regional pride and allow continued growth of the sport among younger and female players. Regarding the Fichtner Park component, this would update facilities that can be used by countless community members - from skateboarders to shortstops and from families to individuals - but with a redesign that makes it even more accessible, safe, and usable. Finally, the trail system has a few stretches already in place, with two more slated for completion in the coming weeks. This would move the final stages of the multi-section trail from an unknown future to a known and exciting now. All three projects have demonstrated regional value and clear community support. A recent community survey garnered nearly 1,000 residential completions (and more than 1,000 with residents who would benefit from these recreational opportunities) and all three components garnered more than 50% support - with the trail system leading the way with more than 70% of respondents in favor. 1. Description of Proposal for Use of Federal Funds *

As noted earlier, the total initiative cost is \$19.31 million, with \$4.57 million for the trail system, \$3.9 million for Fichtner Park, and \$10.84 million for the ice arena. All three of these projects are expected to have a positive health impact in our area, as these varied options can be utilized by people of varying interests and abilities. All three projects are also expected to have a positive economic impact to our area, through the creation of jobs, the attraction of much-needed visitors to this region, and more. Finally, all three projects provide extraordinary benefit beyond the City of Hermantown's borders, as our growing city provides a great deal of recreation opportunities for neighboring communities.

2. Description of Importance to Minnesota *

In our portion of Minnesota, health outcomes are not strong - which have a negative impact not just on our area, but the entire state. There is an economic cost, but also a social cost as well. Improving health outcomes in our area by leaning into community recreation opportunities will not only have a positive impact on the health and well-being of those in our immediate region of the state, but also a positive impact state-wide as our health outcomes improve. When St. Louis County - geographically one of the largest counties in the country - is able to tackle this issue with new resources and new tools, the entire state will feel the benefit. We are seeing small steps forward on this front already with the state, local, and private investment in the Essentia Wellness Center. This gathering space for health, wellness, and community have shown immediate benefits on the individual level that we know will translate to improved health. The pandemic taught us about the limitations of a single facility, so the proposed components extend that commitment to improved health beyond a solitary building. We also believe that these approaches, creative partnerships, and the hard decisions to make these investments can provide a playbook for other Minnesota and midwestern communities to embrace healthier lifestyle choices in ways that leverage the strong community atmospheres they already exhibit.

3. Description of Benefit to Local Community *

Again, the focus on improved health outcomes is the most important benefit, which we know will translate into positives regarding financial and economic outcomes. Regarding the trail system, we have a region that is clamoring for greater non-motorized trail access and this would close a large un-trailed hole in the map and connect several communities with one of the state's premier trail systems - the Willard Munger. Fichtner Park will take the step forward to being the park it was always intended to be - a central, regional park with several access points and available to all. Finally, and simply put, we have more hockey demand than we have the facilities to handle our love of our state's most well-known game. With more and more young people - especially females - participating in the sport and greater numbers of adults staying active in the sport past high school and college, we need a facility that serves an entire region's love of hockey and not just one high school.
