#### REQUESTED ACTION

Hold the first reading of an ordinance increasing the sales tax by .5% effective April 1, 2023

#### BACKGROUND

Following the passage of the referendum regarding increasing the sales tax by .5% for the Community Recreation Initiative, the City Council must revise its ordinance to make the sales tax effective. This is the first step in a process outlined by the State of Minnesota Department of Revenue.

A second reading will be scheduled for December 19<sup>th</sup>. The City Council will also be asked to adopt a Resolution on December 19<sup>th</sup> 2022. The ordinance and resolution will be provided to the State of Minnesota Department of Revenue. We must file this paper work with the State in order for the collection of sales tax can begin April 1, 2023.

By February 8, 2023, the City will have to amend its current agreement with the Department of Revenue to collect the additional tax.

The Department of Revenue will notify the businesses of the increased tax, and the City must publish it on their website.

#### THE CITY COUNCIL OF THE CITY OF HERMANTOWN DOES ORDAIN: AN ORDINANCE ADOPTING AMENDED AND RESTATED TITLE 4 OF THE CITY OF HERMANTOWN CITY CODE, MUNICIPAL SALES TAX

- **Section 1.** <u>Code Adopted.</u> There is hereby adopted "Amended and Restated Title 4 of the Hermantown City Code, Municipal Sales Tax." A copy of such code shall be marked "Official Copy" and filed as part of the official records of the City of Hermantown in the office of the City Clerk and included in the Code of Ordinances for the City.
- Section 2. Statutory Authorization. This Ordinance is authorized by Article 2, Section 29 of Chapter 471, of Laws of 1996, which was approved by the Hermantown City Council on May 22, 1996 and the voters of the City of Hermantown on November 5, 1996 and by Laws 2006, Chapter 259, Article 3, Section 3 and by Laws 2011, Chapter 7, Article 4, Section 4 which was approved by the Hermantown City Council on December 19, 2011 by Resolution No. 2011-106 and on December 3, 2012 by Resolution No. 2012-147 and the voters of the City of Hermantown on November 6, 2012 and by Laws 2021, First Special Session, Chapter 14, Article 8, Section 8 which was approved by the Hermantown City Council on August 2, 2021 by Resolution No. 2021-89 and the voters of the City of Hermantown on November 8, 2022.
- **Section 3.** Copies. The City Clerk shall provide a sufficient quantity of the "Title 4 of the City of Hermantown City Code, Municipal Sales Tax" for general distribution to the public.
- **Section 4.** <u>Prima Facie Evidence</u>. "Title 4 of Hermantown City Code, Municipal Sales Tax" shall be prima facie evidence of the law of the City of Hermantown.
- **Section 5.** Effective Date. This Ordinance and the provisions of "Title 4 of the Hermantown City Code, Municipal Sales Tax" shall be effective after adoption immediately upon the publication of this ordinance once in the legal newspaper of the City of Hermantown.

#### 240.05 Municipal Sales Tax.

- **240.01.1 Authority**. The Minnesota Legislature has by Laws of Minnesota for 1996, Chapter 471, Article 2, Section 29, as amended by Laws 2006, Chapter 259, Article 3, Section 3 and; by Laws 2011, Chapter 7, Article 4, Section 4, and by Laws 2021, First Special Session, Chapter 14, Section 8 authorized the City to impose a one and five tenths percent (1.05%) sales and use tax within the City to provide revenues to pay certain costs related to the funding of extending a sewer interceptor line, construction of a booster pump station, reservoirs, and related improvements to the water system, and construction of a building containing a police and fire station and, an administrative services facility and the Community Recreation Initiative. The City of Hermantown approved the State Laws in accordance with applicable law.
- **240.01.2 Definitions**. The words, terms, and phrases used in Section 4.01 to Section 4.13 shall have the meaning ascribed to them in Minnesota Statutes, Section 297A.61, except where the context clearly indicates otherwise. In addition, the following definitions shall apply:
- **240.05.2.1** "State Laws" means Laws 1996, Chapter 471, Article 2, Section 29, as amended by Laws 2006 Chapter 259, Article 3, Section 3-and, Laws 2011, 1sp-First Special Session, Chapter 7, Article 4-and Laws 2021, First Special Session, Chapter 14, Article 8, Section 8
  - **240.05.2.2** "City" means the City of Hermantown
- **240.05.2.3** "Commissioner" means the Commissioner of Revenue for the State of Minnesota, acting under the authority of an agreement entered into between the City and the State of Minnesota pursuant to the State Laws, or such other person or entity designated to administer and collect the Hermantown Sales Tax.
- **240.05.2.4** "Hermantown Sales Tax" means the sales and use tax imposed and collected pursuant to this Title 4.
  - **240.05.2.5** "Title 4" means this Title 4 of the Hermantown City Code.
- **240.05.2.6** "Retailer maintaining a place of business in the City" or any like term, shall mean any retailer having or maintaining within the City, directly or by a subsidiary, an office, place of distribution, sales or sample room or place, warehouse, or other place of business, or having any representative, agent, salesperson, canvasser, or solicitor operating in the City under the authority of the retailer or its subsidiary, for any purpose, including the repairing, selling, delivering, installing, or soliciting of orders of the retailer's goods or services, or the leasing of tangible personal property located in the City, whether the place of business or agent, representative, salesperson, canvasser, or solicitor is located in the City permanently or temporarily, or whether or not the retailer of subsidiary is authorized to do business within this City.
- **240.05.3 Sales Tax**. Except as otherwise provided in this Title 4, there is hereby imposed—s a Hermantown sales and use tax in the amount of one and five tenths percent (1.5%)

one percent on the gross receipts from sales at retail which are taxable pursuant to Minnesota Statutes, Chapter 297A and occur within the City of Hermantown.

**240.05.4 Application to State General Sales Tax**. The tax imposed under this Article is intended to be collected for the most part on the same items as the state general sales and use tax imposed by Minnesota Statutes, Chapter 297A and consequently the application and administration of the Hermantown Sales Tax shall be construed consistent with the State general sales and use tax and the imposition of the Hermantown Sales Tax shall be construed so that any subsequent amendment to Minnesota Statutes, Chapter 297A affecting the sales or uses taxable under Chapter 297A shall also apply to Hermantown and affect in the same manner the sales taxable under this Title 4.

Provided, however, that in the event any subsequent amendment to Minnesota Statutes, Chapter 297A exempts sales or uses which were taxable under Chapter 297A on April 1, 1997, the City may by amendment hereto extend the tax imposed hereby to any such sales or uses upon compliance with and as provided by the provisions of the Act.

<u>240.05.6240.05.5</u> **Exemptions**. The following are specifically exempted from the Hermantown Sales Tax imposed this Title 4.

240.05.6.1240.05.5.1 The gross receipts from the sale of tangible personal property which the seller delivers to a common carrier for delivery outside the City, places in the United States mail or parcel post directed to a purchaser outside the City, or delivers to the purchaser outside the City by means of the seller's own delivery vehicles, and which is not thereafter returned to a point within the City, except in the course of interstate or intrastate commerce.

240.05.6.2240.05.5.2 The gross receipts from the sale of packing materials used to pack and ship household goods, the ultimate destination of which is outside the City and which are not thereafter returned to a point within the City, except in the course of interstate commerce.

240.05.6.3240.05.5.3 The gross receipts from the sale of and the storage of material designed to advertise and promote the sale of merchandise or services, which material is purchased and stored for the purpose of subsequently shipping or otherwise transferring outside the City by the purchaser for use thereafter solely outside the City. Mailing and reply envelopes and cards used exclusively in connection with the advertising and promotional materials are included in this exemption.

240.05.6.4240.05.5.4 All mobile transportation equipment and parts and accessories attached to or to be attached to such equipment acquired by a person who is engaged in interstate for-hire transportation of tangible personal property or passengers by motor vehicle. Persons referred to herein are: (1) persons possessing a certificate or permit authorizing for-hire transportation of property or passengers from the interstate commerce commission or the Minnesota public utilities commission; or (2) persons transporting commodities defined as "exempt" in for-hire transportation in interstate commerce; or (3) persons who, pursuant to contracts with person described in clauses (1) or (2) above, transport tangible personal property in interstate commerce; or (4) persons who in the course of their business are transporting solely their own goods in interstate commerce.

240.05.7240.05.6 Separate Statement; Collection from Purchaser; Advertising No Tax; Minimum; Uniform Tax Collection Methods. The Hermantown Sales Tax shall be stated and charged separately from the sales price or charge for service insofar as practical and shall be a debt from the purchaser to the seller recoverable at law in the same manner as other debts. In computing the tax to be collected as the result of any transaction amounts of tax less than one-half of one cent may be disregarded and amounts of tax one-half cent or more may be considered an additional cent. If the sale price of any sale at retail is ninety-nine cents or less, no tax shall be collected.

240.05.8240.05.7 Exemption Certificates. An exemption certificate taken in good faith from a purchaser to the effect that the property purchased is for resale or that the sale is otherwise exempt from the application of the tax imposed by this Title 4 conclusively relieve the retailer from collecting and remitting the tax. A person who has obtained from the Commissioner an exemption certificate pursuant to Minnesota Statutes Section 297A.72 may use such exemption certificate for the purposes of the sales tax imposed by the City.

<u>240.05.9240.05.8</u> Presumption of Purposed of Sale. For the purpose of the proper administration and enforcement of this Title 4, it shall be presumed that all retail sales for delivery in the City are for storage, use, or other consumption in the City until the contrary is established.

240.05.10240.05.9 Collection of Sales Tax at Time of Sale. (a) Any retailer making deliveries within the City, any retailer maintaining a place of business in the City, or any other retailer otherwise doing business within the City, upon making sales of any items described in this Title 4 which are not exempted from the sales tax imposed under this Title 4 and which are to be delivered within the City to the purchaser, shall at the time of making such sales collects the Hermantown Sales Tax from the purchaser. The tax collected by such retailer shall be remitted to the Commissioner on behalf of the City.

240.05.10.1240.05.9.1 Any retailer required to collect the Hermantown Sales Tax and remit such tax to the Commissioners pursuant to this section shall register with the Commissioner and provide such other information as the Commissioner may require.

240.05.10.2240.05.9.2 Agent of Retailer. When, in the opinion of the Commissioner, it is necessary for the efficient administration of the tax, the Commissioner may regard any salesman, representative, trucker, peddler, or canvasser as the agent of the dealer, distributor, supervisor, employer, or other person under whom such salesman, representative, trucker, peddler, or canvasser operates or from whom the tangible property is being sold is obtained, and may regard the dealer, distributor, supervisor, employer, or other person as a retailer for the purposes of this Title 4.

240.05.11 240.05.10 Effective Date, Transitional Sales. Except as otherwise provided herein, the Hermantown Sales Tax authorized by this Title 4 shall continue to apply to sales made on or after April 1, 1997 November 8, 2022, and shall be in addition to all other taxes now in effect. The increase from one percent (1.0%) one-half percent (0.5%) to one and five tenths percent (1.5%) one percent (1.0%) authorized by voters at the November 68, 2012 2022 election shall take effect as soon as the Commissioner can implement such change.

The Hermantown Sales Tax shall not apply to: (a) the gross receipts from retail sales or leases of tangible personal property made pursuant to a bona fide written contract which unconditionally vests the rights and obligations of the parties hereto, provided that such contracts were enforceable prior to April 1, 1997, and that delivery of the tangible personal property subject thereto is made on or before April 1, 1997; (b) the gross receipts from retail sales made pursuant to a bona fide lump sum or fixed price construction contract which unconditionally vests the rights and obligations of the parties thereto and which does not make provision for allocation of future taxes, provided that such contract was enforceable prior to April 1, 1997, and that delivery of the tangible personal property used in performing such construction contract is made before April 1, 1997; payments made prior to April 1, 1997, for contracts to provide taxable services, provided that such contracts were enforceable prior to April 1, 2013; however, the Hermantown Sales Tax shall apply to payments made pursuant to such contracts to provide services on and after April 1, 1997; and (d) utility bills that include charges for service for any dated before April 1, 1997, however, the Hermantown Sales Tax shall apply to all utility bills for service provided after April 1, 1997.

**240.05.13 Collection and Enforcement**. The Hermantown Sales Tax imposed by the City pursuant to this Title 4 shall be subject to the same interest, penalties, and other rules as are applicable to the State general sales and use tax imposed by Minnesota Statutes, Chapters 289A and 297A. The Hermantown Sales Tax imposed by the City pursuant to this Title 4 may be collected by the State of behalf of the City as provided by an appropriate agreement with the Commissioner.

240.05.14240.05.12 Tax Clearance; Issuance of Licenses. The City may not issue or renew a license for the conduct of a trade or business in the City if the Commissioner notifies the City that the applicant for such license owes delinquent Hermantown Sales Taxes as provided in this Title 4, or penalties or interest due on such taxes.

For the purpose of this Section, the following terms have the meaning given:

240.05.14.1240.05.12.1 "Hermantown Sales Taxes" include sales tax as provided in this Title 4. Penalties and interest are penalties and interest due on taxes included in this definition.

240.05.14.2240.05.12.2 "Delinquent Taxes" does not include a tax liability if (i) an administrative or court action which contests the amount of validity of the liability has been filed or served, (ii) the appeal period to contest the tax liability has not expire, or (iii) the applicant has entered into a payment agreement and is current with the payments.

240.05.14.3240.05.12.3 "Applicant" means an individual if the license is issued to or in the name of an individual or the corporation, partnership or other entity if the license is issued to or in the name of a corporation, partnership or other entity.

A copy of the notice of delinquent taxes given to the City shall also be sent to the applicant taxpayer. In the case of renewal of a license, if the applicant requests a hearing in writing, within 30 days of the receipt of the notice of delinquent taxes, then, a contested case hearing shall be held by the Commissioner under the same procedures as provided in Minnesota Statutes for the State Sales and Use Tax imposed under Minnesota Statutes, Chapter 297A; provided that if a hearing must be held on the State Sales and Use Tax, hearings may be combined.

240.05.15240.05.13 This Ordinance amends and restates Ordinance No. 96-082012-10 in its entirety. The provisions of Ordinance No. 96-082012-10 as amended by Ordinance No. 2020-03 shall continue in full force and effect with respect to all sales made prior to the imposition of the additional one-half percent (0.5%) sales tax authorized by voters on November 68, 20122022.

# CITY OF HERMANTOWN DECLARATION OF RESTRICTIVE COVENANTS AND GRANT OF RIGHT OF FIRST REFUSAL

The City of Hermantown ("City") has a fee simple interest in the real property located in the County of St. Louis, State of Minnesota that is legally described and shown on Exhibit A attached hereto and all facilities situated thereon (collectively referred to as the "Restricted Property") and as owner of such fee title does hereby declare that such interest in the Restricted Property is hereby made subject to the following restrictions and encumbrances:

- 1. For a period of twenty (20) years from the date hereof, the Restricted Property may not be used for any use that is not a permitted use in the P-Public Zone District on the date hereof as described in Section 550.01 of the City of Hermantown Zoning Code, a copy of which is attached hereto as Exhibit B or for use as a medical facility. Provided, however, that nothing in this Declaration of Restrictive Covenants and Grant of Right of First Refusal shall prohibit any use that is related or affiliated with the City owned Essentia Wellness Center.
- 2. The Restricted Property shall remain subject to this City of Hermantown Declaration for twenty (20) years from the date hereof or until it shall be released from the restriction in Section 1 by way of a written release in recordable form signed on behalf of Kevin Kuklis, or his heirs, successors, or assigns ("Kuklis") and such written release is recorded in the real estate records relating to the Restricted Property. This Declaration may not be terminated, amended, or in any way modified without the specific written consent of Kuklis.
- 3. City hereby acknowledges and confirms that the breach of the provisions of this Declaration would cause immediate and irreparable injury, loss and damage to Kuklis and that an adequate remedy at law for such injury, loss or damage may not exist. Therefore, City agrees that, in the event of any such breach, Kuklis shall be entitled to institute and prosecute proceedings in a court of competent jurisdiction to obtain temporary and permanent injunctive relief to enforce any provision hereof. City agrees that the proper venue and jurisdiction of any proceeding brought pursuant to this paragraph shall be in District Court, St. Louis County,

Minnesota sitting in Duluth, Minnesota. If City is found to have violated any term of this Agreement, City shall pay all attorneys' fees and costs incurred by Kuklis in connection with the enforcement of this Agreement. If City is found to have not violated any term of this Agreement, Kuklis shall pay all attorneys' fees and costs incurred by City in connection to the defense of any action brought by Kuklis.

- 4. If City enters into a contract or other similar agreement (a "Contract") for the sale or conveyance of the Property (or any portion thereof) within twenty (20) years from the date hereof, then City shall notify Kuklis thereof within ten (10) days after full execution of such Contract and shall deliver a copy of such Contract to Kuklis concurrently therewith, either personally or by certified U.S. Mail with a return receipt. Kuklis shall have thirty (30) days after receipt of such notice and the Contract to notify City in writing of Kuklis' exercise of its Right of First Refusal to purchase the Property described in the Contract. If Kuklis fails to timely deliver notice of his exercise of the Right of First Refusal, then City shall have the right to sell or convey the Property described in the Contract to such prospective purchaser or pursuant to the terms of the Contract. If Kuklis timely exercises his Right of First Refusal to purchase the Property described in the Contract, then Kuklis and City shall proceed to the closing of the purchase in accordance with the terms of the Contract.
- 5. The restrictive covenants created by this Declaration shall bind the parties, their heirs, successors and assigns and shall burden and run with the Restricted Property.

#### RIGHT OF ENTRY AGREEMENT

This RIGHT OF ENTRY AGREEMENT (this "License") is made as of this \_\_\_\_\_ day \_\_\_\_\_\_, 2022, by and between the City of Hermantown, a Minnesota statutory city, ("City") and Independent School District No. 700 ("Licensee") in response to the following situation:

- A. City and Licensee are working to develop an ice arena expansion ("Ice Arena Expansion") as part of the Community Recreation Initiative.
- B. The Ice Arena Expansion will involve the demolition of the existing administration building on the corner of Ugstad Road and Arrowhead Road.
- C. City and Licensee are considering the relocation of the administration building on the real estate depicted on Exhibit A ("Premises") attached hereto.
- D. This License will allow City and Licensee to being the planning process for such move of the administration building.

NOW, THEREFORE, City and Licensee hereby agree as follows:

- 1. **Grant of Right of Entry.** On and subject to the terms hereof, City grants to Licensee the right to inspect the physical condition of the Premises, including, without limitation, performing or procuring one or more geological or geotechnical studies of the physical composition and stability of the soils on the Premises, any underground structures on the Premises and otherwise determining the suitability of the Premises for the development of buildings and structures (the "Investigations").
- 2. **Term and Termination.** Licensee's right to use the Premises shall begin at 12:01 AM on December 8, 2022 and shall terminate at 11:59 PM on December 8, 2023. Notwithstanding the foregoing, City reserves the right to immediately terminate this License and Licensee's right to use the Premises at any time and for any reason.
- 3. **Licensee's Covenants.** Licensee covenants to City and agrees as follows: (a) Licensee's use of the Premises shall comply with all applicable federal, state, or local laws, rules, regulations, ordinances, and permits; (b) Licensee shall obtain, at its/their sole expense and provide City with copies of, all required permits for its/their activities on the Premises; (c) Licensee shall not grant, create, or suffer any lien, claim, encumbrance, restriction, or other charge to be placed on the Premises or any other property City; (d) any equipment Licensee may place on the Premises and any portion of the Premises altered by Licensee shall be maintained in a safe, neat, and orderly condition so as to protect life and property and so as not to create any public or private nuisance or damage or injury to any persons or property; (e) Licensee shall require any person or entity who it engages to perform the Investigations to agree to be bound by the terms of this Right of entry agreement; (f) upon the expiration hereof, Licensee shall restore the Premises to substantially the same condition as they existed prior to the date hereof and (g) Licensee shall provide copies of all written reports of studies performed on the Premises pursuant to this License.

#### 4. Liability.

- 4.1. Each party will be responsible for its own acts and behaviors and results thereof. If any claim or cause of action is asserted against a party in connection with the performance of this License, that party will promptly notify the other party of the claim or cause of action. The parties will seasonally cooperate with each other in the defense of claims and causes of action arising out of the performance of this License.
- 4.2. The terms of this Section shall survive the expiration or termination hereof.

5.1. **Notices.** Notices hereunder shall be given by hand delivery or by overnight mail, postage prepaid, as addressed below and shall be effective when received. The City was working with SSLCWCD (South St. Louis County Water Conservation District) and Trout Unlimited on the Keene's Creek restoration in Keene's Creek Park where the creek goes under the roadway entering the park for work in 2023.

This Grant will cover the City's 10% match that was approved by the Council on Sept. 19 (Resolution 22-116) and additional gravel that will be needed to reshape the roadway in the work area after the culvert is installed.
