Section 320 - City Cemetery

320.01 Eligibility. The following shall, upon their death, be entitled to be buried in the City of Hermantown Cemetery:

- **320.01.1.** Persons who have resided in the City for 30 years or more;
- **320.01.2.** Persons who are landowners and residents of the City for at least five consecutive years at the time of their death;
- **320.01.3.** Persons who were landowners and residents of the City for at least five consecutive years until taking up residence in a skilled care nursing facility;
- **320.01.4.** Persons residing in an apartment or other leased or rented dwelling unit in the City at the time of their death if they have resided in the City for five consecutive years; and
- **320.01.5.** Dependent children of persons who shall be entitled to be buried in the City Cemetery.
- **320.02 Reservation of Lots.** No burial lots in the City Cemetery may be reserved by any person eligible to be buried therein. Provided, however, that the surviving spouse of a person buried in the City Cemetery may reserve the lot next to the lot in which his or her spouse is buried.
- **320.03 Fees.** The cost for a lot and a burial in the City Cemetery shall be established from time to time by resolution of the Hermantown City Council.
- **320.04 Interpretations.** All questions related to the interpretation and application of this section shall be referred to the City Council for its determination.
- **320.05 Administration.** The City Cemetery shall be maintained and managed by the City Superintendent.

320.06 Limitations.

- **320.06.1.** No burials shall be made at times when the ground is frozen.
- **320.06.2.** No storage of remains shall be done by the City.
- **320.06.3.** No storage of markers shall be done by the City.
- **320.06.4.** No plantings may be made by anyone in the Cemetery other than by the City.
- **320.06.5.** The City Superintendent may, from time to time, establish other rules and regulations as are necessary for the proper maintenance and operation of the Cemetery.

Following the passage of the referendum regarding increasing the sales tax by .5% for the Community Recreation Initiative, the City Council must revise its ordinance to make the sales tax effective. This is the first step in a process outlined by the State of Minnesota Department of Revenue.

This is the second reading of this ordinance. The City Council will also be asked to adopt a Resolution tonight as well. The ordinance and resolution will be provided to the State of Minnesota Department of Revenue. We must file this paper work with the State in order for the collection of sales tax can begin April 1, 2023.

By February 8, 2023, the City will have to amend its current agreement with the Department of Revenue to collect the additional tax.

The Department of Revenue will notify the businesses of the increased tax, and the City must publish it on their website.

- **Section 1.** <u>Code Adopted.</u> There is hereby adopted "Amended and Restated Title 4 of the Hermantown City Code, Municipal Sales Tax." A copy of such code shall be marked "Official Copy" and filed as part of the official records of the City of Hermantown in the office of the City Clerk and included in the Code of Ordinances for the City.
- Section 2. Statutory Authorization. This Ordinance is authorized by Article 2, Section 29 of Chapter 471, of Laws of 1996, which was approved by the Hermantown City Council on May 22, 1996 and the voters of the City of Hermantown on November 5, 1996 and by Laws 2006, Chapter 259, Article 3, Section 3 and by Laws 2011, Chapter 7, Article 4, Section 4 which was approved by the Hermantown City Council on December 19, 2011 by Resolution No. 2011-106 and on December 3, 2012 by Resolution No. 2012-147 and the voters of the City of Hermantown on November 6, 2012 and by Laws 2021, First Special Session, Chapter 14, Article 8, Section 8 which was approved by the Hermantown City Council on August 2, 2021 by Resolution No. 2021-89 and the voters of the City of Hermantown on November 8, 2022.
- **Section 3.** Copies. The City Clerk shall provide a sufficient quantity of the "Title 4 of the City of Hermantown City Code, Municipal Sales Tax" for general distribution to the public.
- **Section 4.** <u>Prima Facie Evidence</u>. "Title 4 of Hermantown City Code, Municipal Sales Tax" shall be prima facie evidence of the law of the City of Hermantown.
- **Section 5.** Effective Date. This Ordinance and the provisions of "Title 4 of the Hermantown City Code, Municipal Sales Tax" shall be effective after adoption immediately upon the publication of this ordinance once in the legal newspaper of the City of Hermantown.

240.05 Municipal Sales Tax.

- **240.01.1 Authority**. The Minnesota Legislature has by Laws of Minnesota for 1996, Chapter 471, Article 2, Section 29, as amended by Laws 2006, Chapter 259, Article 3, Section 3 and; by Laws 2011, Chapter 7, Article 4, Section 4, and by Laws 2021, First Special Session, Chapter 14, Section 8 authorized the City to impose a one and five tenths percent (1.05%) sales and use tax within the City to provide revenues to pay certain costs related to the funding of extending a sewer interceptor line, construction of a booster pump station, reservoirs, and related improvements to the water system, and construction of a building containing a police and fire station and, an administrative services facility and the Community Recreation Initiative. The City of Hermantown approved the State Laws in accordance with applicable law.
- **240.01.2 Definitions**. The words, terms, and phrases used in Section 4.01 to Section 4.13 shall have the meaning ascribed to them in Minnesota Statutes, Section 297A.61, except where the context clearly indicates otherwise. In addition, the following definitions shall apply:
- **240.05.2.1** "State Laws" means Laws 1996, Chapter 471, Article 2, Section 29, as amended by Laws 2006 Chapter 259, Article 3, Section 3-and, Laws 2011, 1sp-First Special Session, Chapter 7, Article 4-and Laws 2021, First Special Session, Chapter 14, Article 8, Section 8
 - **240.05.2.2** "City" means the City of Hermantown
- **240.05.2.3** "Commissioner" means the Commissioner of Revenue for the State of Minnesota, acting under the authority of an agreement entered into between the City and the State of Minnesota pursuant to the State Laws, or such other person or entity designated to administer and collect the Hermantown Sales Tax.
- **240.05.2.4** "Hermantown Sales Tax" means the sales and use tax imposed and collected pursuant to this Title 4.
 - **240.05.2.5** "Title 4" means this Title 4 of the Hermantown City Code.
- **240.05.2.6** "Retailer maintaining a place of business in the City" or any like term, shall mean any retailer having or maintaining within the City, directly or by a subsidiary, an office, place of distribution, sales or sample room or place, warehouse, or other place of business, or having any representative, agent, salesperson, canvasser, or solicitor operating in the City under the authority of the retailer or its subsidiary, for any purpose, including the repairing, selling, delivering, installing, or soliciting of orders of the retailer's goods or services, or the leasing of tangible personal property located in the City, whether the place of business or agent, representative, salesperson, canvasser, or solicitor is located in the City permanently or temporarily, or whether or not the retailer of subsidiary is authorized to do business within this City.
- **240.05.3 Sales Tax**. Except as otherwise provided in this Title 4, there is hereby imposed—s a Hermantown sales and use tax in the amount of one and five tenths percent (1.5%)

one percent on the gross receipts from sales at retail which are taxable pursuant to Minnesota Statutes, Chapter 297A and occur within the City of Hermantown.

240.05.4 Application to State General Sales Tax. The tax imposed under this Article is intended to be collected for the most part on the same items as the state general sales and use tax imposed by Minnesota Statutes, Chapter 297A and consequently the application and administration of the Hermantown Sales Tax shall be construed consistent with the State general sales and use tax and the imposition of the Hermantown Sales Tax shall be construed so that any subsequent amendment to Minnesota Statutes, Chapter 297A affecting the sales or uses taxable under Chapter 297A shall also apply to Hermantown and affect in the same manner the sales taxable under this Title 4.

Provided, however, that in the event any subsequent amendment to Minnesota Statutes, Chapter 297A exempts sales or uses which were taxable under Chapter 297A on April 1, 1997, the City may by amendment hereto extend the tax imposed hereby to any such sales or uses upon compliance with and as provided by the provisions of the Act.

<u>240.05.6240.05.5</u> **Exemptions**. The following are specifically exempted from the Hermantown Sales Tax imposed this Title 4.

240.05.6.1240.05.5.1 The gross receipts from the sale of tangible personal property which the seller delivers to a common carrier for delivery outside the City, places in the United States mail or parcel post directed to a purchaser outside the City, or delivers to the purchaser outside the City by means of the seller's own delivery vehicles, and which is not thereafter returned to a point within the City, except in the course of interstate or intrastate commerce.

240.05.6.2240.05.5.2 The gross receipts from the sale of packing materials used to pack and ship household goods, the ultimate destination of which is outside the City and which are not thereafter returned to a point within the City, except in the course of interstate commerce.

240.05.6.3240.05.5.3 The gross receipts from the sale of and the storage of material designed to advertise and promote the sale of merchandise or services, which material is purchased and stored for the purpose of subsequently shipping or otherwise transferring outside the City by the purchaser for use thereafter solely outside the City. Mailing and reply envelopes and cards used exclusively in connection with the advertising and promotional materials are included in this exemption.

240.05.6.4240.05.5.4 All mobile transportation equipment and parts and accessories attached to or to be attached to such equipment acquired by a person who is engaged in interstate for-hire transportation of tangible personal property or passengers by motor vehicle. Persons referred to herein are: (1) persons possessing a certificate or permit authorizing for-hire transportation of property or passengers from the interstate commerce commission or the Minnesota public utilities commission; or (2) persons transporting commodities defined as "exempt" in for-hire transportation in interstate commerce; or (3) persons who, pursuant to contracts with person described in clauses (1) or (2) above, transport tangible personal property in interstate commerce; or (4) persons who in the course of their business are transporting solely their own goods in interstate commerce.

240.05.7240.05.6 Separate Statement; Collection from Purchaser; Advertising No Tax; Minimum; Uniform Tax Collection Methods. The Hermantown Sales Tax shall be stated and charged separately from the sales price or charge for service insofar as practical and shall be a debt from the purchaser to the seller recoverable at law in the same manner as other debts. In computing the tax to be collected as the result of any transaction amounts of tax less than one-half of one cent may be disregarded and amounts of tax one-half cent or more may be considered an additional cent. If the sale price of any sale at retail is ninety-nine cents or less, no tax shall be collected.

240.05.8240.05.7 Exemption Certificates. An exemption certificate taken in good faith from a purchaser to the effect that the property purchased is for resale or that the sale is otherwise exempt from the application of the tax imposed by this Title 4 conclusively relieve the retailer from collecting and remitting the tax. A person who has obtained from the Commissioner an exemption certificate pursuant to Minnesota Statutes Section 297A.72 may use such exemption certificate for the purposes of the sales tax imposed by the City.

<u>240.05.9240.05.8</u> Presumption of Purposed of Sale. For the purpose of the proper administration and enforcement of this Title 4, it shall be presumed that all retail sales for delivery in the City are for storage, use, or other consumption in the City until the contrary is established.

240.05.10240.05.9 Collection of Sales Tax at Time of Sale. (a) Any retailer making deliveries within the City, any retailer maintaining a place of business in the City, or any other retailer otherwise doing business within the City, upon making sales of any items described in this Title 4 which are not exempted from the sales tax imposed under this Title 4 and which are to be delivered within the City to the purchaser, shall at the time of making such sales collects the Hermantown Sales Tax from the purchaser. The tax collected by such retailer shall be remitted to the Commissioner on behalf of the City.

240.05.10.1240.05.9.1 Any retailer required to collect the Hermantown Sales Tax and remit such tax to the Commissioners pursuant to this section shall register with the Commissioner and provide such other information as the Commissioner may require.

240.05.10.2240.05.9.2 Agent of Retailer. When, in the opinion of the Commissioner, it is necessary for the efficient administration of the tax, the Commissioner may regard any salesman, representative, trucker, peddler, or canvasser as the agent of the dealer, distributor, supervisor, employer, or other person under whom such salesman, representative, trucker, peddler, or canvasser operates or from whom the tangible property is being sold is obtained, and may regard the dealer, distributor, supervisor, employer, or other person as a retailer for the purposes of this Title 4.

240.05.11 240.05.10 Effective Date, Transitional Sales. Except as otherwise provided herein, the Hermantown Sales Tax authorized by this Title 4 shall continue to apply to sales made on or after April 1, 1997 November 8, 2022, and shall be in addition to all other taxes now in effect. The increase from one percent (1.0%) one-half percent (0.5%) to one and five tenths percent (1.5%) one percent (1.0%) authorized by voters at the November 68, 2012 2022 election shall take effect as soon as the Commissioner can implement such change.

The Hermantown Sales Tax shall not apply to: (a) the gross receipts from retail sales or leases of tangible personal property made pursuant to a bona fide written contract which unconditionally vests the rights and obligations of the parties hereto, provided that such contracts were enforceable prior to April 1, 1997, and that delivery of the tangible personal property subject thereto is made on or before April 1, 1997; (b) the gross receipts from retail sales made pursuant to a bona fide lump sum or fixed price construction contract which unconditionally vests the rights and obligations of the parties thereto and which does not make provision for allocation of future taxes, provided that such contract was enforceable prior to April 1, 1997, and that delivery of the tangible personal property used in performing such construction contract is made before April 1, 1997; payments made prior to April 1, 1997, for contracts to provide taxable services, provided that such contracts were enforceable prior to April 1, 2013; however, the Hermantown Sales Tax shall apply to payments made pursuant to such contracts to provide services on and after April 1, 1997; and (d) utility bills that include charges for service for any dated before April 1, 1997, however, the Hermantown Sales Tax shall apply to all utility bills for service provided after April 1, 1997.

240.05.13 Collection and Enforcement. The Hermantown Sales Tax imposed by the City pursuant to this Title 4 shall be subject to the same interest, penalties, and other rules as are applicable to the State general sales and use tax imposed by Minnesota Statutes, Chapters 289A and 297A. The Hermantown Sales Tax imposed by the City pursuant to this Title 4 may be collected by the State of behalf of the City as provided by an appropriate agreement with the Commissioner.

240.05.14240.05.12 Tax Clearance; Issuance of Licenses. The City may not issue or renew a license for the conduct of a trade or business in the City if the Commissioner notifies the City that the applicant for such license owes delinquent Hermantown Sales Taxes as provided in this Title 4, or penalties or interest due on such taxes.

For the purpose of this Section, the following terms have the meaning given:

240.05.14.1240.05.12.1 "Hermantown Sales Taxes" include sales tax as provided in this Title 4. Penalties and interest are penalties and interest due on taxes included in this definition.

240.05.14.2240.05.12.2 "Delinquent Taxes" does not include a tax liability if (i) an administrative or court action which contests the amount of validity of the liability has been filed or served, (ii) the appeal period to contest the tax liability has not expire, or (iii) the applicant has entered into a payment agreement and is current with the payments.

240.05.14.3240.05.12.3 "Applicant" means an individual if the license is issued to or in the name of an individual or the corporation, partnership or other entity if the license is issued to or in the name of a corporation, partnership or other entity.

A copy of the notice of delinquent taxes given to the City shall also be sent to the applicant taxpayer. In the case of renewal of a license, if the applicant requests a hearing in writing, within 30 days of the receipt of the notice of delinquent taxes, then, a contested case hearing shall be held by the Commissioner under the same procedures as provided in Minnesota Statutes for the State Sales and Use Tax imposed under Minnesota Statutes, Chapter 297A; provided that if a hearing must be held on the State Sales and Use Tax, hearings may be combined.

240.05.15240.05.13 This Ordinance amends and restates Ordinance No. 96-082012-10 in its entirety. The provisions of Ordinance No. 96-082012-10 as amended by Ordinance No. 2020-03 shall continue in full force and effect with respect to all sales made prior to the imposition of the additional one-half percent (0.5%) sales tax authorized by voters on November 68, 20122022.

SUMMARY OF ORDINANCE NO. 2022-14, AN ORDINANCE ADOPTING AMENDED AND RESTATED TITLE 4 OF THE HERMANTOWN CITY CODE, MUNICIPAL SALES TAX

The following is the official summary of Ordinance No. 2022-14, an Ordinance Adopting Amended and Restated Title 4 of the Hermantown City Code, Municipal Sales Tax, ("Ordinance") of the Hermantown Code of Ordinances was approved by the City Council of the City of Hermantown on December 19, 2022.

The primary purpose of the amendment and restatement of the Ordinance is to reflect the additional 0.5% Sales and Use Tax for the Community Recreation Initiative which was authorized by the Minnesota Statute Legislature by Laws 2021, First Special Session, Chapter 14, Article 8, Section 8 and approved by Hermantown voters on November 8, 2022.

The updates by the Ordinance to Section 240.05 of the Hermantown City Code will allow the City to impose a sales and use tax in the amount of 1.5% on the gross receipts from sales at retail which are taxable pursuant to Minnesota Statutes, Chapter 297A and occur within the City of Hermantown.

The foregoing is a summary of a lengthy and detailed Ordinance. The full text of the Ordinance is on file in the office of the City Clerk of the City of Hermantown, 5105 Maple Grove Road, Hermantown, MN 55811, during regular business hours.

If there are any inconsistencies between this summary and the full text of the Ordinance, the terms of the full Ordinance shall govern.

The Ordinance is effective upon publication of this summary.

AGREEMENT

THIS AGREEMENT is between the CITY OF HERMANTOWN, a duly organized City within the County of St. Louis within the State of Minnesota, hereinafter referred to as "CITY OF HERMANTOWN", and the COUNTY OF ST. LOUIS, a duly organized county within the State of Minnesota, hereafter referred to as "ST LOUIS COUNTY".

WITNESSETH:

WHEREAS, ST LOUIS COUNTY intends to undertake a Chip Sealing project on various paved roads (CP 0000-655516), hereinafter referred to as the "County Project"; and

WHEREAS, CITY OF HERMANTOWN intends to undertake a Chip Sealing project on Stebner Road between Maple Grove Road and Highway 53 (CP 0000-739352); hereinafter referred to as the "City of Hermantown Project"; and

WHEREAS, the County Project and City of Hermantown Project shall be hereinafter referred to together as the "Project"; and

WHEREAS, ST LOUIS COUNTY shall prepare a contract for the construction of the County Project and City of Hermantown Project as provided for below intended for letting and construction as a single, unitary construction project in 2023 (the "Contract"), and it is justified and mutually beneficial for CITY OF HERMANTOWN and ST LOUIS COUNTY to combine these projects to mutually benefit from economies of scale, mobilization, and contract administration; and

WHEREAS, ST LOUIS COUNTY will advertise, bid, and enter into a contract with the low bidder for construction of the Project.

THEREFORE, IT IS MUTUALLY AGREED AND UNDERSTOOD, with regard to the aforementioned project, of ST LOUIS COUNTY's and CITY OF HERMANTOWN's paved streets and highways the parties hereby agree to the following:

- 1. ST LOUIS COUNTY shall prepare plans and specifications for the construction of the Project. ST LOUIS COUNTY shall include the plans and specifications in the proposed bid package, from which the costs for the City of Hermantown Project will be determined by the bid prices in accordance with the terms of the proposal.
- 2. ST LOUIS COUNTY and CITY OF HERMANTOWN shall perform, by contract, the construction work provided for in the Plan, with the construction costs of the County Project covered by the County and the construction costs of the City of Hermantown Project covered by the CITY OF HERMANTOWN. ST LOUIS COUNTY, shall prepare bid documents by compiling pay items from the County Project and City of Hermantown Project, and shall award the contract for said projects to the lowest

responsible bidder in accordance with current specifications. After contract letting, and prior to contract award, ST LOUIS COUNTY will provide CITY OF HERMANTOWN with an abstract of all bids received. CITY OF HERMANTOWN will promptly review bid information. The County will award the Contract if the low bid is no more than 20 percent over the engineers estimate for the City of Hermantown Project without further approval from the CITY OF HERMANTOWN.

- 3. ST LOUIS COUNTY shall perform all construction engineering, staking, inspection, material certification and acceptance, and measurement of all items in accordance with State Aid standard for the Project.
- 4. All further costs for change orders, work orders and supplemental agreements related to the County Project shall be allocated to and paid for by the County. All further costs for change orders related to the City of Hermantown Project shall be allocated to and paid for by CITY OF HERMANTOWN.
- 5. CITY OF HERMANTOWN will pay ST LOUIS COUNTY \$1,000 for plan preparation and construction administration
- 6. ST LOUIS COUNTY shall take all actions necessary to prepare the Project for construction, including, but not limited to obtaining any and all applicable environmental permits as required by law, temporary storage sites, temporary or permanent easements, and site restoration at its cost and expense.
- 7. In the event that CITY OF HERMANTOWN takes any action, except as authorized by this Agreement that results in lost time or efficiency or a delay of completion of the County's construction of the County Project, CITY OF HERMANTOWN shall bear the full financial responsibility for any claims or causes of action arising therefrom.
- 8. CITY OF HERMANTOWN will pay to ST LOUIS COUNTY, within thirty (30) days after award of Contract, an amount equal to ninety-five percent (95%) of the estimated cost of CITY OF HERMANTOWN's portion of the City of Hermantown's Project, based on the contract unit prices as contained in the successful Contractor's bidding documents.
- 9. CITY OF HERMANTOWN shall make final payment to ST LOUIS COUNTY after final acceptance of the City of Hermantown Project. Payment will be due within thirty (30) days of receipt of a valid statement of final Contract quantities for CITY OF HERMANTOWN's cost as described herein. If any funds are received by ST LOUIS COUNTY in excess of the project costs, they will be returned to CITY OF HERMANTOWN without interest.
- 10. ST LOUIS COUNTY shall require all contractors and subcontractors performing work on the project described in this agreement to name CITY OF HERMANTOWN

as an insured party in the amounts listed in the insurance requirements contained in the Plan.

- 11. CITY OF HERMANTOWN shall indemnify, hold harmless and defend ST LOUIS COUNTY, its officers and employees against any and all liability, loss, costs, damages, expenses, claims or actions, including attorney's fees which ST LOUIS COUNTY, its officers or employees may hereafter sustain, incur or be required to pay, arising out of or by reason of any act or omission of CITY OF HERMANTOWN, its agents, servants or employees, in the execution, performance, or failure to adequately perform CITY OF HERMANTOWN 's obligations pursuant to this Agreement.
- 12. ST LOUIS COUNTY shall indemnify, hold harmless and defend CITY OF HERMANTOWN its officers and employees against any and all liability, loss, costs, damages, expenses, claims or actions, including attorney's fees which CITY OF HERMANTOWN, its officers or employees may hereafter sustain, incur or be required to pay, arising out of or by reason of any act or omission of ST LOUIS COUNTY, its agents, servants or employees, in the execution, performance, or failure to adequately perform ST LOUIS COUNTY 's obligations pursuant to this Agreement.
- 13. To the full extent permitted by law, actions by the Parties pursuant to this Agreement are intended to be and shall be construed as a "cooperative activity" and it is the intent of the Parties that they shall be deemed a "single governmental unit" for the purpose of liability, as set forth in Minnesota Statutes, Section 471.59, Subd. 1a; provided further that for purposes of that statute, each Party to this Agreement expressly declines responsibility for the acts or omissions of the other Party.
- 14. Each party designates an Authorized Representative for the purpose of administering this Agreement. A party's authorized representative has the authority to give and receive notices, and to make any other decision required or permitted by this Agreement.

IT IS FURTHER AGREED, that any and all employees of CITY OF HERMANTOWN, while engaged in the performance of any work or service which CITY OF HERMANTOWN is specifically required to perform under this Agreement, shall be considered employees of CITY OF HERMANTOWN only and not of ST LOUIS COUNTY, and that any and all claims that may or might arise under the Workers Compensation Act of the State of Minnesota on behalf of said employees while so engaged and any and all claims made by any third parties as a consequence of any act, of said employees, shall be the sole obligation of CITY OF HERMANTOWN.
