
1. Contractor's Schedule




7. Safety

- a. Property Owners
 - i. Rhonda Zacher 4212 Ugstad Rd had question on upcoming construction schedule and how it might affect her upcoming grad party and moving needs.
 - 1. Concrete at driveway was poured last week on June 21
 - 2. 7 day cure period would be up tomorrow 6/28
 - 3. Access to driveway should be available by end of this week, getting a trailer for moving needs this weekend should not be an issue.
 - 4. Grad Party July 8th Paving on Ugstad Rd is planned for July 5-7, assuming current schedule holds, Grad party on July 8th should not be an issue.
 - ii. Rachel Rodlund 4211 Ugstad when will last few driveways get completed, why the stop short on a few driveways near them?
 - 1. Reason for stopping short is those last few driveways are still in the 7 day cure period for the concrete that was poured.
 - 2. The contractor does not want to drive heavy equipment over the new concrete to finish paving driveways until the concrete has had sufficient time to cure.
