## 1. Contractor's Schedule

- a. Contract time Completion Date October 20, 2023
- **b.** Work in progress Current Week
  - i. Prime Contractor Ulland Brothers
    - 1. Reclaiming of Ugstad Rd from Falcon Dr to Williams Dr is complete.

- 2. Calcium chloride was applied to Ugstad Rd for dust suppression.
- 3. Culvert extensions up by USH 53 and storm sewer catch basins and outfalls on Ugstad Rd.
- 4. Drain tile along Ugstad Rd north of Arrowhead Rd
- 5. Paving last remainder of bituminous driveways this week on Ugstad Rd south of Arrowhead Rd.
- ii. Subcontractors O'Connor, Northwoods Sodding
  - 1. Milling of existing bituminous pavement on Ugstad Rd was completed on Monday.
  - 2. Remainder of existing pavement from Twin Pines Dr to USH 53 was removed due to numerous locations have less than minimum pavement thickness, resulting in areas where entire pavement was removed.
  - 3. Northwoods sodding has completed sodding, topsoiling, and blanketing on Ugstad Rd from Maple Grove Rd to Lavaque Junction.

  - 1. Continue on drain tile
  - 2. Storm sewer crossings of Ugstad Rd near hockey arena
  - 3. Start subcut on Ugstad Rd north of Arrowhead Rd.
  - 4. Possibly start hydrant extensions.
- ii. Subcontractors -Warning Lites Northwoods Sodding, JMF
  - 1. Warning Lites Stage 2 Detour signage still needs to be completed.
  - 2. Northwoods sodding continue restoration work on Ugstad Rd north of Lavaque Junction
  - 3. JMF could be on site to do spot curb and gutter replacement on north end of Ugstad Rd.

- c. MnDOT Paul Ackerley with MnDOT recommended that the Type III barricade with the ROAD CLOSED sign up near USH 53 be pulled off the road more. Currently its in the SB lane and traffic leaving USH 53 onto SB Ugstad Rd need to swerve around the sign into oncoming NB Ugstad Rd traffic.

    - 1. Ulland is sending SWPPP reports upon request by MSA.


