

1. Contractor's Schedule


- a. Contract time Completion Date October 20, 2023
- **b.** Work in progress Current Week
 - i. Prime Contractor Ulland Brothers
 - 1. Working on centerline culverts on Ugstad Rd near Arena
 - 2. Paving of last remaining driveways and subcut area on Ugstad Rd south of Arrowhead Rd.
 - 3. Small amount of milling to be completed between Lavaque Junction and subcut in front of Essentia Health YMCA.
 - 4. Working on centerline pipework.
 - 5. Removing existing entrance (shown below) at admin building and paving straight through per City's request.



- 7. Driveway at 4111 Ugstad Rd will have sections of bituminous driveway removed and replaced this week.
- ii. Subcontractors Northwoods Sodding, Parsons, Mavo
 - 1. Northwoods Sodding has been out watering sod.
 - 2. Parsons has been checking in and is being pushed back until curb is being placed. May set bases on Arrowhead so they are on site.
 - 3. Mavo on site for saw cutting
- c. Work in progress Next Week
 - i. Prime Contractor Ulland Brothers
 - 1. Hydrants to be replaced
 - a. Wet tap at STA 558+20 to be completed Monday. Paul Senst to verify size of watermain. Needed to ensure correct saddle.
 - Tuesday water shutdown for Hydrant removal and installation at 515+64
 LT
 - c. Wednesday water shutdown for hydrant removal at 556+90 and installation at 558+20
 - d. Ulland will distribute door hangers to notify residents of water main shut down by Friday July 28th this week.
 - 2. Start subcutting on Ugstad Rd north of Arrowhead Rd. Once complete, crew will move to Arrowhead Rd.
 - ii. Subcontractors Northwoods Sodding, JMF
 - 1. JMF should be on-site for curb & gutter.
 - 2. Northwoods Sodding for continued sod maintenance.

 - i. None at this time.


2. Utilities




3. Traffic Control

a. Issues – Vehicles driving onto oncoming traffic at Ugstad Rd & USH 53. Paul Ackerley reiterated that traffic cannot be forced into oncoming lanes when Type III barricades are blocking a through lane as shown below:



Ulland has moved Type III Barricade out of the through lanes so this issue does not happen again. Will monitor for any continued issues. If issues persist, suggest traffic control layout as shown below and close left turn lane:


