- **b.** Work in progress Current Week
 - i. Prime Contractor Ulland Brothers
 - 1. Hydrant on Ugstad Rd near Gethsemane Church was installed on Tuesday.
 - 2. Last hydrant infront of hockey arena on Ugstad Rd is being installed today.
 - 3. Finish subcutting on Ugstad Rd north of Arrowhead Rd.
 - 4. Prep for concrete curb & gutter early next week.
 - 5. Mailboxes being placed starting today.
 - ii. Subcontractors Northwoods Sodding, Parsons
 - 1. Northwoods Sodding has been out watering sod.
 - Herness is on site today installing mailboxes on Ugstad Rd from Maple Grove Rd to Arrowhead Rd


- a. Certification / test report submittals
- b. QC Testing
 - i. Ulland sent over copies of tests reports for three gradation tests taken on site stockpile of Select Granular Embankment Mod 7%. All three tests met specifications
- c. QA Testing -
 - Braun took three samples two at Ulland's Scanlon pit and one of stockpile material last week and ran gradations. All three tests of this material being classified as Select Granular Embankment Mod 7% passed.
 - ii. MSA reminded group that sidewalk construction on Ugstad Rd from Arrowhead Rd, north, to USH 53 will required density tests every 500 LF done on subgrade and aggregate base class 5.
 - iii. Ulland requested that tolerancing of Aggregate Base Class 5 be done immediately behind grader so if things need to be adjusted then grader can remediate while still on site.
