
#### 1. Contractor's Schedule

- a. Contract time Completion Date October 20, 2023
- **b.** Work in progress Current Week
  - i. Prime Contractor Ulland Brothers
    - 1. Subcut on Ugstad Rd north of Arrowhead Rd completed this week.
    - 2. Prepping for sidewalk and curb pours next week
    - 3. Culvert extension for 30" culvert discovered last week up near USH 53 on Ugstad Rd extended this week
    - 4. Begin removals on Arrowhead Rd this week.
      - a. MSA to mark removals this week.
  - ii. Subcontractors Northwoods Sodding, JMF
    - 1. Northwoods Sodding has been out watering sod.
    - 2. JMF setting strings Friday or Saturday.
      - a. JMF will contact Braun for testing needs this week.
      - MSA to post door hangers today by Friday to remind residents that they will start to lose driveway access beginning Monday due to concrete pours.
- c. Work in progress Next Week

- i. Prime Contractor Ulland Brothers
  - 1. Stage 3 detour will be in place by Monday August 14th.
  - 2. Milling on Arrowhead Rd to be completed Monday August 14th.

  - 1. JMF to pour curb Monday & Tuesday, driveway aprons on Wednesday.


- b. Businesses Essentia Wellness Center
