AN ORDINANCE AMENDING AND RESTATING CHAPTER 1020, FIRE CODE, OF THE HERMANTOWN CITY CODE

Section 1. <u>Purpose and Intent</u>. The purpose and intent of this Ordinance is to amend and restate Chapter 1020, Fire Code, in its entirety to accurately reflect updated statutory amendments in Chapter 1020 of the Hermantown City Code by adopting uniform fire safety standards set by the Minnesota State Fire Code. The primary purpose of the Minnesota State Fire Code is to provide minimum standards to safeguard life and limb, health, property and public welfare covered by the Hermantown Fire Code in the City of Hermantown.

Section 2. <u>Amendment to Chapter 1020</u>. Chapter 1020, Fire Code, is hereby amended and restated to read as shown on <u>Exhibit A</u> attached hereto.

Section 3. <u>Amended and Inserted in the Code</u>. After the restatement of Chapter 1020 made by this ordinance becomes effective, it shall be inserted in the appropriate place in the Hermantown City Code.

Section 4. <u>Effective Date</u>. The provisions of this Ordinance shall be effective after adoption and immediately upon publication once in the official newspaper of the City of Hermantown.

EXHIBIT A

Section 1020 - Fire Code

1020.01-<u>Scope</u>.

1020.01.1. The purpose of these <u>This Chapter establishes</u> regulations shall be to adopt uniform fire safety standards governing the maintenance of buildings and premises; regulating the storage, use and handling of dangerous and hazardous materials, substances and processes; and regulating the maintenance of adequate egress facilities. These provisions shall be collectively adopted for the purpose of protecting the interests of the municipality as a whole against fire hazards. No inspections carried out in furtherance of this Section shall be for the purpose of assuring either the person inspected or third parties that any structure or property shall be free from all fire hazards. In particular, no inspection carried out pursuant to Section 1020.09 shall be construed as assuring that the day care center that is inspected shall be free from all fire hazards.affecting or relating to structures, processes, premises and safeguards regarding all of the following:

1020.01.1 The hazard of fire and explosion arising from the storage, handling or use of structures, materials or devices.

<u>1020.01.2</u> Conditions hazardous to life, property or public welfare in the occupancy of structures or premises.

<u>1020.01.3</u> Fire hazards in the structure or on the premises from occupancy or <u>operation.</u>

<u>1020.01.4</u> Matters related to the construction, extension, repair, alteration or removal of fire suppression or alarm systems.

<u>**1020.01.5**</u> Conditions affecting the safety of fire fighters and emergency responders during emergency operations.

<u>1020.1020.01.2.01.6.</u> This Section shall be collectively referred to as the Hermantown Fire Code.

1020.02. Minnesota State Fire Code Adopted. The Minnesota State Fire Code, established pursuant to Minnesota Administrative Rules Chapter 7511, as may be amended from time to time by the Minnesota Department of Public Safety, shall hereby be adopted as the Hermantown Fire Code for the City of Hermantown and shall be adopted into this Section, with the exception of the Optional Appendices described in Section 1020.02.1 unless specifically adopted by this Chapter.

Storage tanks containing liquefied petroleum gases located within 25 feet of any driveway, parking lot or other area where motor vehicles may be driven shall be protected by a fenced enclosure. The fenced enclosure shall be located at least 24 inches from all sides of the storage tank and be constructed of noncombustible material at least 60 inches high, have an access gate not less than 36 inches wide and be posted with no smoking signs on all sides. Prior to the erection of the enclosure, the Fire Chief shall determine the suitability of the material proposed to be used for the construction of the enclosure and shall advise the owner of the property of his or her determination in writing.

1020.05.2.2. Storage tanks containing liquefied petroleum gases located within ten feet of any driveway, parking lot or other area where motor vehicles may be driven shall be protected by guardrails of sufficient strength to withstand impact from a motor vehicle. The guardrail shall be located on all sides of the storage tank that could be struck by a motor vehicle. Prior to the erection of the guardrail, the Fire Chief shall determine the suitability of the materials proposed to be used for the construction of the guardrail and shall advise the owner of the property of his or her determination in writing.

1020.05.2.3. All storage tanks containing liquefied petroleum gases shall be placed on reinforced concrete pads. The area of the concrete pad and an area 24 inches on each side of the pad shall be kept free of all vegetation and combustible material.

1020.05.2.4. Alternate methods of protecting storage tanks containing liquefied petroleum gases may be approved by the Fire Chief provided that the alternate method shall provide the same degree of protection to the tanks as shall be provided by the methods prescribed by this section.

1020.05.2.5. The provisions of this Section shall be applicable to all installations of storage tanks containing liquefied petroleum gases in the City. Installations in place on the effective date of this Section shall meet the requirements of this Section within six months of the effective date of the enactment of this code.

1020.06 Establishment of Districts.

1020.06.1. With respect to the limits referred to in Section 3401 of the Uniform Fire Code, storage of flammable or combustible liquids in outside above ground tanks shall

be allowed only in M1 and M2 Zone Districts, and only if the property on which the tanks are to be located shall be served by an adequate water supply for fire protection.

1020.06.2. With respect to the limits referred to in Section 3402 of the Uniform Fire Code, new bulk plants for flammable or combustible liquids shall be allowed only in M1 and M2 Zone Districts, and only if the property on which the plants are to be located shall be served by an adequate water supply for fire protection.

1020.07 Removal of Abandoned Underground Storage Tanks.

1020.07.1. Any underground combustible liquid storage tank that has not been used for a period of one year shall be removed from the ground by the owner of the property within which the tank is located and the hole resulting from the removal properly filled within 30 days of a written order from the Fire Chief to the owner of the property directing that the tank be removed from the ground. For purposes of this section, the owner of the property shall be as shown on the most recent records of the St. Louis County Auditor.

1020.07.2. The removal of any tank ordered to be removed by the Fire Chief pursuant to this Section shall be accomplished in a manner approved by the Fire Chief. The Fire Chief shall, without limiting the generality of the foregoing, require:

1020.07.2.1. That all flammable or combustible liquids be removed from the tank and from any connecting lines prior to the removal of the tank from the ground;

1020.07.2.2. That all piping be disconnected at all tank openings;

1020.07.2.3. That all connecting lines which are not to be used further be removed from the ground;

1020.07.2.4. That all tank openings be capped or plugged;

1020.07.2.5. That the tank shall be freed from gas vapors after its removal from the ground either on the property from which it is removed, if it can be safely done at that location, or at such other location that the Fire Chief determines that it would be safe to free the tank from the gas vapors; and

1020.07.2.6. That any tank removed from the ground that is to be disposed of as junk be tested for flammable vapors, and if necessary, rendered gas free and a sufficient number of holes or openings be made in the tank to make it unfit for further use as a combustible liquid storage tank.

1020.08 Hydrants on Industrial, Commercial or Multi-Residential Property.

1020.0806.1.-Installation of fire hydrants shall be required on all property in zone districts allowing industrial, commercial and multiple residential uses that abut on and is served by a City waterline. The number and location of fire hydrants shall be determined in accordance with the Uniform Fire Code, and with related sections of the NFPA Code, subject to the following:Code.

1020.08.1.1. There shall be fire hydrants placed at 300 foot intervals along the street right-of-way.

1020.08.1.2. Additional hydrants shall be located in such a manner that the maximum length of hose line from any hydrant shall be 300 feet. Upon approval of fire protection plans and certified fire flow data, the Fire Chief may authorize a maximum hose line length of up to 500 feet.

1020.08.1.3. For Group R-3 and Group U occupancies, the maximum hose length of hose line from any hydrant shall be 250 feet.

1020.08.1.4. For buildings equipped throughout with an approved automatic sprinkler system installed in accordance with Section 903.3.1.1 or 903.3.1.2 of the Uniform Fire Code, the maximum hose length of hose line from any hydrant shall be 250 feet.

1020.08.2. Duly authorized officers of the City may enter upon private property for the purpose of operating and maintaining fire hydrants.

1020.09 Day-Care Centers.

1020.09.1 Definitions. For the purpose of this section, the following definitions shall apply unless the context clearly indicates or requires a different meaning.

1020.09.1.1. "Child" shall mean a person under 14 years of age.

1020.09.1.2. "Day-care center" shall mean a licensed family day- care home, a licensed group family day-care program and a licensed group day-care center as those terms are defined in regulations DPW 2 and DPW 3 of the Minnesota Department of Welfare, as they may be amended from time to time.

1020.09.2 Inspections.

1020.09.2.1. All day-care centers in the City shall be inspected by the Fire Chief or his or her designated representative upon the establishment of the day-care center and each year thereafter to determine whether the requirements of this Section shall be met. The operators of the day-care centers shall allow the

inspections to be made at reasonable times by the Fire Chief or his or her designated representatives.

1020.09.2.2. Day care centers in existence on the effective date of this Section shall be inspected within three months of the effective date of this Section by the Fire Chief or his or her designated representative, and annually thereafter. The operators of the day- care centers shall allow the inspections to be made at reasonable times by the Chief or his or her designated representative.

1020.09.3 Reports of Inspectors.

1020.09.3.1. The Fire Chief or his or her designated representative shall provide the operators of the inspected day care center with a duplicate copy of the day care inspection format completed as appropriate to show where the day care center meets the minimal code provisions as well as where the day-care center shall not meet minimal code requirements.

1020.09.3.2. The Fire Chief or his or her designated representative shall conduct exit interviews at the inspected day care center at the conclusion of every inspection to alert the operators of the day care center to problems discovered in the inspection. The exit interview shall inform the operator of the day-care center of any violations of the Hermantown Fire Code that are discovered, the remedial measures to be taken by the operator to correct the violations and the time period in which the violations shall be corrected.

1020.09.3.3. The Fire Chief or his or her designated representative shall transpose all appropriate information to the appropriate State Fire Marshal standard inspection form and prepare an exit interview report form. A copy of the exit interview report form shall be signed by the Fire Chief or his or her designated representative and the operator of the day-care center and a copy given to the operator of the day-care center at the time of the exit interview.

1020.09.3.4. The Fire Chief or his or her designated representative shall thereafter transmit all pertinent information to the State Fire Marshal and the St. Louis County Social Services Department for further processing and filing. The State Department of Public Welfare and the St. Louis County Social Services Department shall be furnished a copy of the inspection form describing any violations of the Hermantown Fire Code that are discovered.

1020.09.4 Re-inspection. Upon the expiration of the time period for correcting any violations that are discovered, the Fire Chief or his or her designated representative shall re-inspect the premises of the day-care center to determine whether the recommended remedial measures have been taken. A report of the determination of the Fire Chief or his or her designated representative shall be given to the operator of the day care center, the St. Louis County Social Services Department, the State Fire Marshal and the State Department of Public Welfare.

1020.09.5 Enforcement. Notwithstanding anything to the contrary contained in this section, the enforcement of the provisions of the Hermantown Fire Code with respect to day care centers shall be the ultimate responsibility of the State Department of Public Welfare and not the City. The Fire Chief or his or her designated representative shall refer any enforcement action against any day care center to the State Department of Public Welfare.

1020.09A Fire Prevention Division. There shall be hereby continued for and within the government of the City a Fire Prevention Division. The Fire Prevention Division shall be responsible for fire prevention duties including, but not limited to, Code enforcement, conduct of fire inspections, public relations or public information work, fire investigation, the keeping of fire records and any other activity that may have as its ultimate purpose the prevention of fire and the reduction of life and property losses from fire. The Fire Chief and the inspectors designated shall be members of and shall constitute the Fire Prevention Division.

1020.10 Fire Code Appeal Board.

1020.10.1. A Fire Code Appeal Board shall be hereby continued. The Board shall consist of five members to be appointed by resolution of the City Council. Members shall be appointed to serve for two years and thereafter until their successors are duly appointed and qualified. The City Attorney shall act as legal advisor to the Board. Any vacancy occurring in the membership of the Board shall be filled, for the unexpired term only, by resolution of the City Council.

1020.10.2. The members of the Fire Code Appeal Board shall reside in and be registered voters of the City and shall elect from among the appointed members a chairperson. One member shall be a member of the Planning and Zoning Commission of the City; one a member of the Board of Appeals and Adjustments of the City; one a member of the City and two members shall be citizens experienced in real estate and/or the building trades. The members of the Board shall serve without pay.

1020.10.3. The Board shall meet at stated intervals, fixed by resolution of the Board, or at the call of the chairperson or of any two members of the Board.

1020.10.4. The Board shall adopt reasonable rules and regulations for the conduct of its business. It shall render any decisions and findings in writing to the Fire Chief with one duplicate copy to the appellant and another duplicate copy to the State Fire Marshal within 15 days of the decision.

1020.10.5. In special cases the Fire Code Appeal Board may interpret the provisions of the Hermantown Fire Code if it appears that the provisions shall not definitely cover the problem raised.

1020.10.6. On appeal or by request of the Fire Chief, the Fire Code Appeal Board may determine the appropriateness of alternate methods of construction or the use of alternate materials not specifically prescribed by the Hermantown Fire Code. The Board shall approve the method of construction or material only if reasonable proof shall be presented that the method or material shall be at least equivalent to Hermantown Fire Code standards in quality, strength, effectiveness, durability, fire resistance and safety.

1020.10.7. Upon any appeal being brought pursuant to Section 1020.11, the Board shall fix a day of hearing on the appeal and shall give written notice thereof, by mail or personal service, to the party bringing the appeal.

1020.10.8. The Fire Code Appeal Board shall make its decision on any matters properly presented to it by resolution adopted by the majority vote of all of the members voting thereon. The resolution of the Board in each such case shall describe the conditions under which relief shall be granted or variation permitted, and a complete report of the hearing held thereon by the Board, together with a copy of its resolution, shall be submitted to the City Council in each such instance for confirmation or disapproval. No such variation shall become effective unless confirmed by the City Council.

If and when any decision of the Board granting a variation is confirmed by the City Council, the variation so permitted shall apply to all buildings, installations or conditions where the facts are substantially the same as the facts relied upon by it to make its determination. A properly indexed record of all such variations permitted by decision of the Board, which shall be confirmed by the City Council, shall be kept in the office of the Fire Chief and open to public inspection.

1020.10.9. In cases where relief is denied or variation refused by the Board, a complete report of the hearing held thereon by the Board reciting its decision shall be submitted to the City Council in each instance. The City Council may at any time request that the chairperson of the Fire Code Appeal Board, or any member thereof selected by the chairperson, appear before the City Council to further explain the reasons for the action of the Board in any case.

1020.10.10. No member of the Fire Code Appeal Board shall pass upon any question in which he or she shall be personally interested.

1020.11 Appeals.

1020.11.1. Any person affected by any decision of the Fire Chief which is related to or made pursuant to this Section or the code may appeal therefrom to the Fire Code Appeal Board established by Section 1020.10. An appeal may be taken by the affected party serving the Fire Chief with written notice of intention to appeal the Fire Chief's decision within ten days after the affected party received knowledge or notice of the decision.

1020.11.2. The notice of appeal shall contain a complete statement of the matter in controversy, and, if from a refusal of a permit for use of alternate materials or type of construction, shall contain a guarantee of payment of all expenses of any tests made or ordered by the Fire Code Appeal Board. The notice shall be accompanied by a fee as set by the Fee Schedule, as it may be amended from time to time to be retained by the City.

1020.11.3. Any such appeal shall be subject to and shall be conducted in accordance with the provisions of Section 1020.10.

1020.11.4. A copy of any decision or finding of the Board relative to any appeal made pursuant to this Section shall be provided to the Fire Chief by the Board.

1020.12 New Materials, Processes or Occupancies; Permits. The Building Official, the Fire Chief and the Fire Inspector of the City shall act as a committee to determine and specify, after giving affected persons an opportunity to be heard, any new materials, processes or occupancies which shall require fire protection permits under the Hermantown Fire Code, in addition to those now enumerated in the Minnesota Uniform Fire Code or the NFPA Code. The Fire Chief shall post a list of the additional permits required in a conspicuous place in his or her office and distribute copies thereof to interested persons.

1020.13 07. Severability. In the event any clause or provision of this Section shall be determined to be illegal or unconstitutional, the determination shall not affect the validity of the remaining provisions of this section.

1020.14-<u>08.</u> Limitation of Liability. The City, the Fire Chief or his or her designated representative, and any employee charged with the enforcement of this section, shall not be liable for any damage that may occur to persons or property as a result of any act required of the Fire Chief, his or her designated representative or any employee herein or by reason of any act or omission of the Fire Chief, his or her designated representative or any such employee.

1020.15 <u>09.</u> Violations; Penalties.

1020.15.1. The application of the above penalty shall not be held to prevent the enforced removal of prohibited conditions as provided this section.

1020.15.2. When a person fails to eliminate a fire hazard as ordered by the Fire Chief, the Fire Chief may eliminate the hazard. Every person who fails to obey such an order shall be individually liable for the cost incurred by the ChiefCity in eliminating the hazard.

1020.1509.3. Where the Fire Chief eliminates such a hazard, the City shall have a lien upon the real property upon which the fire hazard existed, and upon the personal property which constituted the fire hazard.

1020.1509.4. The lien shall be in the amount of the cost of eliminating the hazard and shall attach to real property when a statement of claim therefrom is filed for record

with the County Recorder or Registrar of Titles of St. Louis County. The lien shall attach to personal property when a statement of the claim therefor is filed for record with the City Clerk.

1020.1509.5. It is further unlawful to give or make or cause to be given or made, an alarm of a fire without probable cause, or to neglect or refuse to obey any reasonable order of the Fire Chief <u>or the Incident Commander</u> at a fire, or to interfere with the Fire Department in the discharge of its duties.

1020.16 Fires or Barbecues on Balconies or Patios.

1020.16.1. In any structure containing two or more dwelling units, no person shall kindle, maintain, or cause any fire or open flame on (i) any balcony above ground level, or (ii) on any ground floor patio within 15 feet of the structure.

1020.16.2. No person shall store or use any fuel, barbecue, torch, or other similar heating or lighting chemical or device on (i) any balcony above ground level, or (ii) on any ground floor patio within 15 feet of the structure.

1020.16.3. Electrical or gas-fired barbecue grills that are permanently mounted and plumbed or wired to the building's gas supply or electrical system, and that maintain a minimum clearance of 18 inches on all sides, unless listed for lesser clearances, may be installed on balconies and patios when approved by the Fire Chief.

AN ORDINANCE AMENDING AND RESTATING CHAPTER 1020, FIRE CODE, OF THE HERMANTOWN CITY CODE

Section 1. <u>Purpose and Intent</u>. The purpose and intent of this Ordinance is to amend and restate Chapter 1020, Fire Code, in its entirety to accurately reflect updated statutory amendments in Chapter 1020 of the Hermantown City Code by adopting uniform fire safety standards set by the Minnesota State Fire Code. The primary purpose of the Minnesota State Fire Code is to provide minimum standards to safeguard life and limb, health, property and public welfare covered by the Hermantown Fire Code in the City of Hermantown.

Section 2. <u>Amendment to Chapter 1020</u>. Chapter 1020, Fire Code, is hereby amended and restated to read as shown on <u>Exhibit A</u> attached hereto.

Section 3. <u>Amended and Inserted in the Code</u>. After the restatement of Chapter 1020 made by this ordinance becomes effective, it shall be inserted in the appropriate place in the Hermantown City Code.

Section 4. <u>Effective Date</u>. The provisions of this Ordinance shall be effective after adoption and immediately upon publication once in the official newspaper of the City of Hermantown.

EXHIBIT A

Section 1020 - Fire Code

1020.01. Scope. This Chapter establishes regulations affecting or relating to structures, processes, premises and safeguards regarding all of the following:

1020.01.1 The hazard of fire and explosion arising from the storage, handling or use of structures, materials or devices.

1020.01.2 Conditions hazardous to life, property or public welfare in the occupancy of structures or premises.

1020.01.3 Fire hazards in the structure or on the premises from occupancy or operation.

1020.01.4 Matters related to the construction, extension, repair, alteration or removal of fire suppression or alarm systems.

1020.01.5 Conditions affecting the safety of fire fighters and emergency responders during emergency operations.

1020.01.6. This Section shall be collectively referred to as the Hermantown Fire Code.

1020.02. Minnesota State Fire Code Adopted. The Minnesota State Fire Code, established pursuant to Minnesota Administrative Rules Chapter 7511, as may be amended from time to time by the Minnesota Department of Public Safety, shall hereby be adopted as the Hermantown Fire Code for the City of Hermantown and shall be adopted into this Section, with the exception of the Optional Appendices described in Section 1020.02.1 unless specifically adopted by this Chapter.

1020.02.1. Optional Appendices. The following optional appendices identified in the most current edition of the Minnesota State Fire Code:

1020.02.1.1 Appendix B, Fire-Flow Requirements for Buildings.

1020.02.1.2. Appendix C, Fire Hydrant Locations and Distribution.

1020.02.1.3. Appendix D, Fire Apparatus Access Roads.

1020.02.1.4. Appendix E, Hazard Categories.

1020.02.1.5. Appendix F, Hazard Ranking.

1020.02.1.6. Appendix G, Cryogenic Fluids—Weight and Volume Equivalents.

1020.02.1.7. Appendix H, Hazardous Materials Management Plan (HMMP) and Hazardous Materials Inventory Statement (HMIS) Instructions.

1020.02.1.8. Appendix I, Fire Protection Systems—Noncompliant Conditions.

1020.02.1.9. Appendix K, Construction Requirements for Existing Ambulatory Care Facilities.

1020.02.1.10. Appendix N, Indoor Trade Shows and Exhibitions.

1020.02.1.11. Appendix O, Fires or Barbecues on Balconies or Patios.

1020.03. Definitions. For the purpose of this section, the following definitions shall apply unless the context clearly indicates or requires a different meaning.

1020.03.1. "City Council" shall mean the City Council of the City.

1020.03.2. "Code" shall mean the Hermantown Fire Code.

1020.03.3. "Corporation counsel" shall mean the attorney for the City.

1020.03.4. "Fire Chief" or "Chief" shall mean the Fire Chief of the Fire Department serving the City.

1020.03.5. "Jurisdiction" shall mean the City.

1020.04. Enforcement.

1020.04.1. The Fire Chief or his or her duly authorized representative shall enforce the provisions of the Code.

1020.04.2. The Fire Chief may designate such members of the Fire Department serving the City as part of the Fire and Life Safety Division as shall from time to time be necessary. The designation shall be confirmed by the City Council. The City Building Official is hereby designated as a technical officer. During the course of the duties as technical officer, the City Building Official may encounter fire and life safety deficiencies regulated by the Code. The City Building Official is authorized to make initial inspections and issue deficiency corrective actions pursuant to the Code and shall refer such matters to the Fire Chief. The City Building Official is also authorized to assist the Fire Department with investigations to advise on the structural soundness and fire and life safety capabilities of a structure.

1020.04.3. All fees for permits required under the Minnesota State Fire Code or any regulations of the State Fire Marshal that are adopted by this Section shall be collected by the City Clerk and deposited in the general fund of the City.

1020.04.4. All occupancies requesting a temporary change to occupancy type and/or load shall apply for a temporary use permit. All temporary use permits shall require a Fire and Life Safety Division visit by a Fire Department designee.

1020.04.5. All permits issued under this Section shall be valid for such period designated on the permit.

1020.05. Bulk Storage of Liquefied Petroleum Gases.

1020.05.1 Bulk storage of facilities for liquefied petroleum gas shall comply with the National Fire Protection Association, Liquefied Petroleum Gas Code (NFPA 58) and Minnesota Rules Chapter 7511.6012.

1020.06. Hydrants on Industrial, Commercial or Multi-Residential Property.

1020.06.1. Installation of fire hydrants shall be required on all property in zone districts allowing industrial, commercial and multiple residential uses that abut on and is served by a City waterline. The number and location of fire hydrants shall be determined in accordance with the Code.

1020.06.2. Duly authorized officers of the City may enter upon private property for the purpose of operating and maintaining fire hydrants.

1020.07. Severability. In the event any clause or provision of this Section shall be determined to be illegal or unconstitutional, the determination shall not affect the validity of the remaining provisions of this section.

1020.08. Limitation of Liability. The lien shall attach to personal property when a statement of the claim therefor is filed for record with the City Clerk.

1020.09.5. It is further unlawful to give or make or cause to be given or made, an alarm of a fire without probable cause, or to neglect or refuse to obey any reasonable order of the Fire Chief or the Incident Commander at a fire, or to interfere with the Fire Department in the discharge of its duties.

This AGREEMENT FOR NAMING RIGHTS ("Agreement") is entered into as of January 23, 2024, by and between Duluth Ford Limited Liability Company, a limited liability company under the laws of the State of Wyoming ("Company") and the **City of Hermantown**, a municipal corporation ("City"), and the **Independent School District No. 700** ("School District");

WHEREAS, School District owns and operates the Hermantown ice arena; and

WHEREAS, the City is following through on a strong community desire to have increased recreational opportunities, including adding an additional sheet of indoor ice to the current hockey arena; and

WHEREAS, it is known that the current single sheet of indoor ice is currently unable to support the full-scope of community members of all ages who wish to participate; and

WHEREAS, City will lead the development of the Project and has approved entering into this Agreement with Company, the terms of which are expressed herein to grant to Company the exclusive naming rights and other benefits and rights as set forth herein for a period of twenty (20) years (the "Rights"), with respect to the Project, in exchange for the fees being paid by Company.

NOW THEREFORE, in consideration of the mutual covenants and agreements herein contained and other good and valuable consideration, the receipt and sufficiency of which is acknowledged, the parties agree as follows:

1. The above stated Recitals are hereby incorporated herein.

51

2. <u>Term.</u> Company shall have naming rights, as described herein, for (a) the two ice rinks and (b) the Hermantown Hockey Arena improved as part of the Project, for twenty (20) years commencing with the date the Project is issued a certificate of completion. School District and City reserve the naming rights for all other subordinate portions of the Project.

3. <u>Project Name</u>. The official name of the Project will be Northstar Ford Arena, unless amended or changed in accordance with this Agreement, and the Project will be referred to as "Northstar Ford Arena" whenever referenced by School District and City. The parties will meet in good faith to determine the appropriate guidelines for usage of the name.

4. <u>Exclusive Negotiation Right to Extension Term</u>. Unless sooner terminated in accordance with the provisions set forth elsewhere in this Agreement, Company, School District, and the City agree to enter into negotiations for a ten (10) year extension of this Agreement during the one-year period prior to the end of the Term. The negotiation and resulting terms of the extension will be based on objective rates from comparable projects. Company will have the right of first refusal for naming rights at the end of the Term and shall negotiate in good faith with School District and City with respect to the purchase of the naming rights during that one-year period prior to the end of the Term. In the event the School District, City and Company do not reach an agreement to extend the naming rights past the Term, School District and City shall have no further obligation to Company, nor shall Company have any further obligation to the School District and City pursuant to this Agreement.

5. <u>Specifics as to Rights.</u> The specific rights accorded to Company, in consideration of the fee payment set forth in Section 5, are as follows:

5.1. The Project will be known as the "Northstar Ford Arena". It will be so noted in all directives, signage, brochures, advertising, promoting, and marketing of the Project. There will be two exterior illuminated signs displaying the Company name, one located on the south wall of the Project and one located on the east wall of the Project as depicted in the Signage Plan with no other exterior signage of other sponsors.

5.2. The current existing ice sheet will be named "Ford", with the new ice sheet named "NorthStar" as depicted in the signage plan referenced in Section 6 of this Agreement. This will be noted with signage at the entrances to each ice sheet as depicted in the signage plan. The School District logo(s) shall be at center ice of both sheets of ice (2). For the avoidance of doubt, it is contemplated that the design of the ice sheet arena name and School Hawk logo shall be similar in nature to the University of Minnesota-Duluth Bulldog log and Amsoil Arena logo set forth upon Exhibit A attached hereto.

5.3. Four dasher boards will be provided for each ice sheet for Company designated advertisement. Two of the dasher boards on each ice sheet will be located at the home team bench seating area and one dasher board will be located in each of the two corners that are viewable from the site that broadcasting equipment would be placed for video recording a game for television or internet broadcasting.

5.4. Company will be allowed to rent at no-cost, subordinate to the rights of the

current lessee of the Project facilities, the Hermantown Area Hockey Association, ("HAHA") at mutually agreeable times up to three (3) dates annually for limited use of Project facilities for Company employee related gatherings or other Company social activities, pursuant to the standard form of facility rental agreement utilized by HAHA for such activities.

5.5. Company designated names will appear as a sponsor on each of the scoreboards within the Project (but not as the primary scoreboard sponsor).

- 5.6 Company will receive eight (8) season passes good at eligible school events, specifically not including MSHSL playoff events, occurring at the Project.
- 5.7 All signs, dasher boards, or other fixtures displaying the Company name shall be removed at the Company's expense at the end of this Agreement, or any extension thereof.

6. <u>Further Rights.</u> The parties shall agree to a Signage Plan ("Signage Plan"), for the Project that includes signage on the exterior of the Project building, the entrance for each rink as described herein. The parties shall not unreasonably delay or withhold their approval of a Signage Plan. Company shall pay for the design, installation, and costs of the exterior signage and the interior signage for each rink entrance referenced in this Agreement. All other costs shall be the responsibility of the City. Any changes subsequent to the original decisions as to the location, design, and dimensions of any of the Rights may be proposed by Company, the School District or City and are subject to the approval of the other parties, not to be unreasonably withheld or delayed. The party requesting the change shall be responsible for additional costs incurred because of change.

7. <u>Rights Fees.</u>

7.1. In consideration of the rights and services provided by the City under the provisions of this Agreement, Company agrees to pay to the City the amount of One Million Six Hundred Thousand and No/100 Dollars (\$1,600,000.00). Within thirty (30) days of execution of this Agreement, Company shall provide a payment of two hundred fifty thousand dollars (\$250,000.00) to the City ("Initial Payment"). The remaining amount of the fees shall be delivered in semi-annual installments beginning on the earlier of January 1st or July 1st, and then on those dates thereafter semi-annual payments for nine (9) years in the amount of Seventy-five Thousand and No/100 dollars (\$75,000.00).

7.2. Interest will accrue on any payment that is more than twenty (20) days late in the amount of five percent (5%) per annum.

8. Signage and Sponsorship Exclusivity. In addition to the naming rights granted herein, City agrees not to offer, grant, or sell the right to name any subordinate portion of the Project or to place any permanent or temporary signs, or allow for advertising pertaining to the Project to any third party whose primary business falls within the business category of sales of trucks and automobiles. In the event City proposes to sell subordinate naming rights to a third $\frac{53}{53}$

party in the same business category, City agrees to submit to Company the identity of the third party for Company's prior written approval, which may be withheld by Company at its sole discretion. City and School shall cause HAHA to ensure that no existing advertising contracts at the Project in the primary business category of sales of trucks and automobiles shall be renewed at the conclusion of the 2023-2024 high school hockey season.

9. <u>Copyrights, Trademarks, Service Marks, Logo, and Similar Rights.</u> During the term of this Agreement, the parties agree that Company will develop a graphic design incorporating the name to be used as the primary logo associated with the Project. Company may develop derivative graphic designs related to the primary logo to be issued periodically for ancillary marketing and promotional purposes pursuant to this Agreement. The City agrees not to take any action which will impair any of the copyrights, trademarks, service marks, logos, and similar rights of Company during the term of this Agreement. At all times, the School District will have exclusive rights of its logo, and Company shall not use the School District logo without express permission from the School District.

10. <u>License to City</u>. Company grants to City a non-transferable, non-exclusive, royaltyfree license to the names, marks, and logos collectively referred to as the "Northstar Ford Marks." Company owns or has licensed the right to use and to license the Northstar Ford Marks.

11. <u>Assignment of Name</u>. All parties have the right to assign its rights and responsibilities as set forth in this Agreement subject to the consent of the other parties but said consent shall not be unreasonably withheld.

12. <u>Other Naming Rights.</u> City intends, subject to the rights provided to Company herein, to offer sponsorship rights directly or through Project partners to donors to the Project for activities related to the Project or for component parts of the Project.

13. <u>Data Practices.</u> Company understands that the City is subject to the provisions of the Minnesota Government Data Practices Act.

14. <u>Compliance</u>. This Agreement is subject to the terms of, and each party hereby agrees to comply with all applicable laws, statutes, rules, regulations, decisions, and orders in the performance of this Agreement.

15. <u>Governing Law and Venue.</u> This Agreement shall be governed and construed in accordance with laws in the State of Minnesota. Any action to enforce this Agreement shall be brought in the Courts of the state of Minnesota and the Parties shall be entitled to any and all remedies available at law, including but not limited to injunctive relief.

16. <u>Termination and Suspension.</u>

16.1. In the event that events or circumstances cause the entire facility to be shut down and unavailable for use for longer than ninety (90) days, e.g. a pandemic, Company agrees to continue to make payments of the rights fees herein and the City agrees that for whatever period of time the shutdown continues, the term of this Agreement shall be 54

extended, without further payment, for a period of time measured by the period of shutdown. Further, in the event that the entire facility closes, for financial or other reasons for a period of more than ninety (90) days, Company shall have the right to suspend payments during such period of closure and the Agreement shall be extended by the period of such closure.

16.2. The parties agree that Company may initiate a renegotiation of the amount payable hereunder if at any point the Project is no longer the primary location in which Hermantown youth hockey teams, including but not limited to the high school boys, play the majority of their home games. If the parties are unable to agree on an amount of reduction an arbitration of an appropriate reduction will be conducted in accordance with the Rules of the American Arbitration Association in effect for commercial disputes with the arbitration conducted within the city of Hermantown, Minnesota.

16.3. In addition to all other rights and remedies available under law, any party may cancel and terminate this Agreement, without liability to the other party, if the defaulting party repudiates, breaches, or otherwise fails to comply with any terms of this Agreement. If any party defaults hereunder, the aggrieved party shall serve a written notice on all parties specifying the nature of the default and demanding that the default be cured. If the defaulting party does not cure within thirty (30) days after receipt of the notice, the aggrieved party may avail itself of all remedies available under the law, including but not limited to, the aggrieved party may terminate this Agreement on a date certain designated in such notice, which date may not be less than sixty (60) days from the date of such notice.

17. <u>Relationship of the Parties.</u> The relationship of Company and the City is that of separate entities and nothing herein or in related documents or representation shall create or imply any relationship, agency, partnership, or joint venture. Each are engaged in separate and independent activities and neither shall state, represent, or imply any interest in each other or the business conducted by them.

18. <u>Representations and Warranties.</u> The parties represent they warrant to each other that they have the legal right and power to enter into this Agreement and that all necessary corporate or governmental approvals relating to this Agreement have been obtained. The parties agree that this Agreement has been duly authorized by resolution, attached as Exhibit B, and executed, and delivered by each of them and is a valid and binding obligation, enforceable against each of them in accordance with its terms.

19. <u>Entire Agreement</u>. This Agreement contains the entire agreement of the parties with respect to the matters provided for herein and supersedes any written or oral agreements, instruments, applications, promotional materials, brochures, or other representations made. No amendments or modifications of this Agreement shall be effective unless the amendment or modification is in writing signed by the Company, School District, and the City. The Parties understand and agree that the terms of this Agreement are contingent upon the execution of Donation Agreement between the Company and HAHA.

20. <u>Notices.</u> Unless otherwise provided herein, any notice, request, demand, waiver, or other communication required or permitted to be given under this agreement shall be provided by (i) certified mail (return receipt requested), or (ii) overnight courier to the receiving party at the address set forth below:

I. PROGRAM INTRODUCTION

This program is intended to accelerate local trail connections to planned and existing state trails and other public facilities, not to create significant new recreation trails. Its primary purpose is to complete connections between where people live (e.g., residential areas within cities, entire communities) and significant public resources (e.g., historical areas, open space, parks and/or other trails).

Grants are awarded for the acquisition and development of connecting trails and for removal of barriers that impede full access to these facilities. Historically, priority has been given to projects that seek to develop residential connections to state and regional facilities and to link existing trail systems.

The Local Trail Connections Program depends on local communities and their local government representatives to provide inspiration, planning and commitment, as well as the local matching financial requirement, to make these trail projects a reality. Local governments complete the acquisition and/or projects and are reimbursed for a portion of the acquisition and/or project actually completed.

The program was first funded in 1993 and has funded 280 trail projects statewide to date.

II. IMPORTANT ITEMS YOU NEED TO KNOW

A. How to Apply

- Anticipated funding available for FY 2025 is approximately \$1.1 million from "In Lieu Of" lottery proceeds. This funding is divided between three Park and Trail grant programs. This funding is subject to appropriation from the MN Legislature and signature of the Governor.
- All applications must be received electronically by March 29, 2024
- Applications are to be submitted electronically in a ".pdf" format by the due date above. Paper submission of applications are not accepted. To submit the application, email a pdf version of the application and attachments to <u>Trailgrants.DNR@state.mn.us</u>. This is the official submittal email box. Submitting to any other email will <u>not</u> be accepted. Format the entire application, including all attachments, as one pdf document with all pages 8 ¹/₂" by 11" in dimension. After submission, make sure you have received a confirmation email that your application has arrived in a useable format by the due date. <u>A</u> confirmation email should arrive within one or two business days after you have submitted your application and after it is reviewed for readability</u>. Each email is opened to insure files are readable and then followed with a confirmation email. Applications submitted in an unusable format will NOT be considered for funding. If there are any questions about submitting the application, please contact program staff.
- Grant awards will be announced by June 2024.
- Funds will first be available no earlier than July 1, 2024 to start the contracting process. This means projects funded in this grant round will not have a contract in place before July 1st and thus cannot begin the project prior to this date (see B. Grant Timeline section).
- All local units of government (typically cities, counties, and townships) are eligible to apply. Also, user groups and/or trail organizations may apply, but only in coordination with a local unit of government per legislation. Funding is only available to a local unit of government.
- The maximum permissible request is \$250,000. The minimum is \$5,000.
- These grants are 75/25 "cash match" reimbursement grants. That means the grantee must complete the project and fully pay for it, produce documentation that shows actual expenditures and proper procurement process has been followed. Then they will receive 75% of what was spent up to their grant award.
 - Neither this funding source, nor the match can be used for in-house labor services and/or to meet existing payroll (see Section III, D. Non-eligible Reimbursement Costs for additional ineligible costs).
 - Only contract services, materials, and supplies are reimbursable.

All projects awarded through this grant round must be completed by **June 30, 2026** and immediately available for use to the general public for no less than 20 years.

- If land is purchased with these funds, it is required that a "Twenty-Year Easement for Recreational Trail Purposes" is attached to the deed. Also, the property must be appraised by a state certified appraiser and in accordance with DNR and Federal requirements. Please see land acquisition and appropriate land appraisal requirements in this manual.
- Trails must be at least 10' wide.
- Applicants are required to design and construct their trail to meet ADA standards, unless it meets an ADA exemption. The applicant must site the exemption from ADA in the application for it to be considered, otherwise provide details and list design specifics in the ADA question of the application in how the project will meet ADA requirements. **Do not just state the trail project will be ADA compliant; this is an insufficient answer.**
- If your project is selected, the project will need to be evaluated for applicability of environmental review under <u>Minnesota Rules</u>, <u>Chapter 4410</u>. The local unit of government listed in the application is considered the Responsible Governmental Unit (RGU). Mandatory EAW categories are described at Minnesota Rules, 4410.4300. Exemptions from environmental review are described at Minnesota Rules, 4410.4600. Verify if your project is or is not exempt.
- If your project is selected, the grantee will need to be evaluated for applicability of preaward risk assessment under Minn. Stat. §16B.981 <u>Chapter 62-MN Laws - Article 7,</u> <u>Section 11</u>.
- All facilities that are funded through this program also require a commitment from the applicant that the trail will be open and available for use, as well as maintained, for no less than twenty years and should be stated in their resolution.
- Each proposal must specifically and directly address each requirement and criterion to qualify and receive consideration. If one section of the application is not addressed, the application will not be reviewed for consideration.
- All pages and attached maps must be <u>8 1/2 X 11 inches ONLY</u> and in color.
- Read each question thoroughly to make sure each part of a question is answered. Do not answer a question inside the same box as the question. Use the blank box associated with each question for the response.
- When identifying recreation use for your project, <u>make sure to only mark those uses that</u> <u>will actually use the trail</u>.
