5. WORK SESSION (Project Updates)

5.1 - Update on additions to the Hermantown Marketplace

Eric Johnson, Joe Wicklund and John Mulder explained that the City would be receiving an land use application for a sports dome on the back soccer fields at Stebner Park. This

will include rezoning the Park from P Public to Hermantonw Marketplace, a special use permit, commercial industrial permit, and a preliminary plat. The rezoning and plat along with a development agreement will have to be reviewed and approved by the City Council as part of the process.

5.2 – Update on Hawkline Business Park

John Mulder presented an update on the Hawkline Business. The City has worked on the project since 2022 and has spent money and received a state grant to complete the Alternate Urban Areawide Review (AUAR). The AUAR generated local and Twin City press along with calls from interested parties including the MN Dept of Employment and Economic Development (DEED). The private owners have created a name and marketing materials for the Business Park. Staff will continue to engage interested parties and work with the owners.
